A *BILL to amend and reenact §§ 3.2-6500 and 58.1-1708 of the Code of Virginia and to amend the Code of Virginia by adding sections numbered 3.2-6504.2, 3.2-6504.3, 3.2-6504.4, and 58.1-1707.1, relating to Companion Animal Surgical Sterilization Program and Fund established.*

**Be it enacted by the General Assembly of Virginia:**

**1. That §§ 3.2-6500 and 58.1-1708 of the Code of Virginia are amended and reenacted and that the Code of Virginia is amended by adding sections numbered 3.2-6504.2, 3.2-6504.3, 3.2-6504.4, and 58.1-1707.1 as follows:**

**§ 3.2-6500. Definitions.**

As used in this chapter unless the context requires a different meaning:

"Abandon" means to desert, forsake, or absolutely give up an animal without having secured another owner or custodian for the animal or by failing to provide the elements of basic care as set forth in § 3.2-6503 for a period of four consecutive days.

"Adequate care" or "care" means the responsible practice of good animal husbandry, handling, production, management, confinement, feeding, watering, protection, shelter, transportation, treatment, and, when necessary, euthanasia, appropriate for the age, species, condition, size and type of the animal and the provision of veterinary care when needed to prevent suffering or impairment of health.

"Adequate exercise" or "exercise" means the opportunity for the animal to move sufficiently to maintain normal muscle tone and mass for the age, species, size, and condition of the animal.

"Adequate feed" means access to and the provision of food that is of sufficient quantity and nutritive value to maintain each animal in good health; is accessible to each animal; is prepared so as to permit ease of consumption for the age, species, condition, size and type of each animal; is provided in a clean and sanitary manner; is placed so as to minimize contamination by excrement and pests; and is provided at suitable intervals for the species, age, and condition of the animal, but at least once daily, except as prescribed by a veterinarian or as dictated by naturally occurring states of hibernation or fasting normal for the species.

"Adequate shelter" means provision of and access to shelter that is suitable for the species, age, condition, size, and type of each animal; provides adequate space for each animal; is safe and protects each animal from injury, rain, sleet, snow, hail, direct sunlight, the adverse effects of heat or cold, physical suffering, and impairment of health; is properly lighted; is properly cleaned; enables each animal to be clean and dry, except when detrimental to the species; during hot weather, is properly shaded and does not readily conduct heat; during cold weather, has a windbreak at its entrance and provides a quantity of bedding material consisting of hay, cedar shavings, or the equivalent that is sufficient to protect the animal from cold and promote the retention of body heat; and, for dogs and cats, provides a solid surface, resting platform, pad, floormat, or similar device that is large enough for the animal to lie on in a normal manner and can be maintained in a sanitary manner. Under this chapter, shelters whose wire, grid, or slat floors (i) permit the animals' feet to pass through the openings, (ii) sag under the animals' weight, or (iii) otherwise do not protect the animals' feet or toes from injury are not adequate shelter. The outdoor tethering of an animal shall not constitute the provision of adequate shelter (a) unless the animal is safe from predators and well suited and well equipped to tolerate its environment; (b) during the effective period for a hurricane warning or tropical storm warning issued for the area by the National Weather Service; or (c)(1) during a heat advisory issued by a local or state authority, (2) when the actual or effective outdoor temperature is 85 degrees Fahrenheit or higher or 32 degrees Fahrenheit or lower, or (3) during the effective period for a severe weather warning issued for the area by the National Weather Service, including a winter storm, tornado, or severe thunderstorm warning, unless an animal control officer, having inspected an animal's individual circumstances in clause (c)(1), (2), or (3), has determined the animal to be safe from predators and well suited and well equipped to tolerate its environment.

"Adequate space" means sufficient space to allow each animal to (i) easily stand, sit, lie, turn about, and make all other normal body movements in a comfortable, normal position for the animal and (ii) interact safely with other animals in the enclosure. When an animal is tethered, "adequate space" means that the tether to which the animal is attached permits the above actions and is appropriate to the age and size of the animal; is attached to the animal by a properly applied collar, halter, or harness that is configured so as to protect the animal from injury and prevent the animal or tether from becoming entangled with other objects or animals,

59 or from extending over an object or edge that could result in the strangulation or injury of the animal; is at  
60 least 15 feet in length or four times the length of the animal, as measured from the tip of its nose to the base  
61 of its tail, whichever is greater, except when the animal is being walked on a leash or is attached by a tether to  
62 a lead line or when an animal control officer, having inspected an animal's individual circumstances, has  
63 determined that in such an individual case, a tether of at least 10 feet or three times the length of the animal,  
64 but shorter than 15 feet or four times the length of the animal, makes the animal more safe, more suited, and  
65 better equipped to tolerate its environment than a longer tether; does not, by its material, size, or weight or  
66 any other characteristic, cause injury or pain to the animal; does not weigh more than one-tenth of the  
67 animal's body weight; and does not have weights or other heavy objects attached to it. The walking of an  
68 animal on a leash by its owner shall not constitute the tethering of the animal for the purpose of this  
69 definition. When freedom of movement would endanger the animal, temporarily and appropriately restricting  
70 movement of the animal according to professionally accepted standards for the species is considered  
71 provision of adequate space. The provisions of this definition that relate to tethering shall not apply to  
72 agricultural animals.

73 "Adequate water" means provision of and access to clean, fresh, potable water of a drinkable temperature  
74 that is provided in a suitable manner, in sufficient volume, and at suitable intervals appropriate for the  
75 weather and temperature, to maintain normal hydration for the age, species, condition, size and type of each  
76 animal, except as prescribed by a veterinarian or as dictated by naturally occurring states of hibernation or  
77 fasting normal for the species; and is provided in clean, durable receptacles that are accessible to each animal  
78 and are placed so as to minimize contamination of the water by excrement and pests or an alternative source  
79 of hydration consistent with generally accepted husbandry practices.

80 "Adoption" means the transfer of ownership of a dog or a cat, or any other companion animal, from a  
81 releasing agency to an individual.

82 "Agricultural animals" means all livestock and poultry.

83 "Ambient temperature" means the temperature surrounding the animal.

84 "Animal" means any nonhuman vertebrate species except fish. For the purposes of § 3.2-6522, animal  
85 means any species susceptible to rabies. For the purposes of § 3.2-6570, animal means any nonhuman  
86 vertebrate species including fish except those fish captured and killed or disposed of in a reasonable and  
87 customary manner.

88 "Animal control officer" means a person appointed as an animal control officer or deputy animal control  
89 officer as provided in § 3.2-6555.

90 "Boarding establishment" means a place or establishment other than a public or private animal shelter  
91 where companion animals not owned by the proprietor are sheltered, fed, and watered in exchange for a fee.  
92 "Boarding establishment" shall not include any private residential dwelling that shelters, feeds, and waters  
93 fewer than five companion animals not owned by the proprietor.

94 "Collar" means a well-fitted device, appropriate to the age and size of the animal, attached to the animal's  
95 neck in such a way as to prevent trauma or injury to the animal.

96 "Commercial dog breeder" means any person who, during any 12-month period, maintains 30 or more  
97 adult female dogs for the primary purpose of the sale of their offspring provided that a person who breeds an  
98 animal regulated under federal law as a research animal shall not be deemed to be a commercial dog breeder.

99 "Companion animal" means any domestic or feral dog, domestic or feral cat, nonhuman primate, guinea  
100 pig, hamster, rabbit not raised for human food or fiber, exotic or native animal, reptile, exotic or native bird,  
101 or any feral animal or any animal under the care, custody, or ownership of a person or any animal that is  
102 bought, sold, traded, or bartered by any person. No agricultural animal or game species, or animal actively  
103 involved in bona fide scientific or medical experimentation shall be considered a companion animal for the  
104 purposes of this chapter.

105 "Consumer" means any natural person purchasing an animal from a dealer or pet shop or hiring the  
106 services of a boarding establishment. The term "consumer" shall not include a business or corporation  
107 engaged in sales or services.

108 "Dealer" means any person who in the regular course of business for compensation or profit buys, sells,  
109 transfers, exchanges, or barter companion animals. The following shall not be considered dealers: (i) any  
110 person who transports companion animals in the regular course of business as a common carrier or (ii) any  
111 person whose primary purpose is to find permanent adoptive homes for companion animals.

112 "Direct and immediate threat" means any clear and imminent danger to an animal's health, safety or life.

113 "Dump" means to knowingly desert, forsake, or absolutely give up without having secured another owner  
114 or custodian any dog, cat, or other companion animal in any public place including the right-of-way of any  
115 public highway, road or street or on the property of another.

116 "Emergency veterinary treatment" means veterinary treatment to stabilize a life-threatening condition,  
117 alleviate suffering, prevent further disease transmission, or prevent further disease progression.

118 "Enclosure" means a structure used to house or restrict animals from running at large.

119 "Euthanasia" means the humane destruction of an animal accomplished by a method that involves

120 instantaneous unconsciousness and immediate death or by a method that involves anesthesia, produced by an  
121 agent that causes painless loss of consciousness, and death during such loss of consciousness.

122 "Exhibitor" means any person who has animals for or on public display, excluding an exhibitor licensed  
123 by the U.S. Department of Agriculture.

124 "Facility" means a building or portion thereof as designated by the State Veterinarian, other than a private  
125 residential dwelling and its surrounding grounds, that is used to contain a primary enclosure or enclosures in  
126 which animals are housed or kept.

127 "Farming activity" means, consistent with standard animal husbandry practices, the raising, management,  
128 and use of agricultural animals to provide food, fiber, or transportation and the breeding, exhibition, lawful  
129 recreational use, marketing, transportation, and slaughter of agricultural animals pursuant to such purposes.

130 "*Feral or free-roaming cat*" means a cat that is unowned, lost, or abandoned.

131 "Foster care provider" means a person who provides care or rehabilitation for companion animals through  
132 an affiliation with a public or private animal shelter, home-based rescue, releasing agency, or other animal  
133 welfare organization.

134 "Foster home" means a private residential dwelling and its surrounding grounds, or any facility other than  
135 a public or private animal shelter, at which site through an affiliation with a public or private animal shelter,  
136 home-based rescue, releasing agency, or other animal welfare organization care or rehabilitation is provided  
137 for companion animals.

138 "Groomer" means any person who, for a fee, cleans, trims, brushes, makes neat, manicures, or treats for  
139 external parasites any animal.

140 "Home-based rescue" means an animal welfare organization that takes custody of companion animals for  
141 the purpose of facilitating adoption and houses such companion animals in a foster home or a system of foster  
142 homes.

143 "Humane" means any action taken in consideration of and with the intent to provide for the animal's  
144 health and well-being.

145 "Humane investigator" means a person who has been appointed by a circuit court as a humane  
146 investigator as provided in § 3.2-6558.

147 "Humane society" means any incorporated, nonprofit organization that is organized for the purposes of  
148 preventing cruelty to animals and promoting humane care and treatment or adoptions of animals.

149 "Incorporated" means organized and maintained as a legal entity in the Commonwealth.

150 "Inspector" means a State Animal Welfare Inspector employed pursuant to § 3.2-5901.1 or his  
151 representative.

152 "Kennel" means any establishment in which five or more canines, felines, or hybrids of either are kept for  
153 the purpose of breeding, hunting, training, renting, buying, boarding, selling, or showing.

154 "Law-enforcement officer" means any person who is a full-time or part-time employee of a police  
155 department or sheriff's office that is part of or administered by the Commonwealth or any political  
156 subdivision thereof and who is responsible for the prevention and detection of crime and the enforcement of  
157 the penal, traffic or highway laws of the Commonwealth. Part-time employees are compensated officers who  
158 are not full-time employees as defined by the employing police department or sheriff's office.

159 "Livestock" includes all domestic or domesticated: bovine animals; equine animals; ovine animals;  
160 porcine animals; cervidae animals; capradae animals; animals of the genus Lama or Vicugna; ratites; fish or  
161 shellfish in aquaculture facilities, as defined in § 3.2-2600; enclosed domesticated rabbits or hares raised for  
162 human food or fiber; or any other individual animal specifically raised for food or fiber, except companion  
163 animals.

164 "*Low-income owner*" means an animal owner who is a resident of Virginia and whose gross annual  
165 income is no more than 125 percent of the poverty standard accepted by the federal agency designated to  
166 establish poverty guidelines.

167 "*Medically unfit*" means unsuitable for a surgical procedure due to any medical condition that may place  
168 a dog or cat at life-threatening risk if a surgical procedure is performed on such an animal, as determined by  
169 a veterinarian.

170 "New owner" means an individual who is legally competent to enter into a binding agreement pursuant to  
171 subdivision B 2 of § 3.2-6574, and who adopts or receives a dog or cat from a releasing agency.

172 "Ordinance" means any law, rule, regulation, or ordinance adopted by the governing body of any locality.

173 "Other officer" includes all other persons employed or elected by the people of Virginia, or by any  
174 locality, whose duty it is to preserve the peace, to make arrests, or to enforce the law.

175 "Owner" means any person, *other than a caretaker of a feral or free-roaming cat*, who: (i) has a right of  
176 property in an animal; (ii) keeps or harbors an animal; (iii) has an animal in his care; or (iv) acts as a  
177 custodian of an animal.

178 "Pet shop" means a retail establishment where companion animals are bought, sold, exchanged, or offered  
179 for sale or exchange to the general public.

180 "Poultry" includes all domestic fowl and game birds raised in captivity.

181 "Primary enclosure" means any structure used to immediately restrict an animal or animals to a limited

182 amount of space, such as a room, pen, cage, compartment, or hutch. For tethered animals, the term includes  
183 the shelter and the area within reach of the tether.

184 "Private animal shelter" means a facility operated for the purpose of finding permanent adoptive homes  
185 for animals that is used to house or contain animals and that is owned or operated by an incorporated,  
186 nonprofit, and nongovernmental entity, including a humane society, animal welfare organization, society for  
187 the prevention of cruelty to animals, or any other similar organization.

188 "Properly cleaned" means that carcasses, debris, food waste, and excrement are removed from the primary  
189 enclosure with sufficient frequency to minimize the animals' contact with the above-mentioned contaminants;  
190 the primary enclosure is sanitized with sufficient frequency to minimize odors and the hazards of disease; and  
191 the primary enclosure is cleaned so as to prevent the animals confined therein from being directly or  
192 indirectly sprayed with the stream of water, or directly or indirectly exposed to hazardous chemicals or  
193 disinfectants.

194 "Properly lighted" when referring to a facility means sufficient illumination to permit routine inspections,  
195 maintenance, cleaning, and housekeeping of the facility, and observation of the animals; to provide regular  
196 diurnal lighting cycles of either natural or artificial light, uniformly diffused throughout the facility; and to  
197 promote the well-being of the animals.

198 "Properly lighted" when referring to a private residential dwelling and its surrounding grounds means  
199 sufficient illumination to permit routine maintenance and cleaning thereof, and observation of the companion  
200 animals; and to provide regular diurnal lighting cycles of either natural or artificial light to promote the well-  
201 being of the animals.

202 "Public animal shelter" means a facility operated by the Commonwealth, or any locality, for the purpose  
203 of impounding or sheltering seized, stray, homeless, abandoned, unwanted, or surrendered animals or a  
204 facility operated for the same purpose under a contract with any locality.

205 "Releasing agency" means (i) a public animal shelter or (ii) a private animal shelter, humane society,  
206 animal welfare organization, society for the prevention of cruelty to animals, or other similar entity or home-  
207 based rescue that releases companion animals for adoption.

208 "Research facility" means any place, laboratory, or institution licensed by the U.S. Department of  
209 Agriculture at which scientific tests, experiments, or investigations involving the use of living animals are  
210 carried out, conducted, or attempted.

211 "Sanitize" means to make physically clean and to remove and destroy, to a practical minimum, agents  
212 injurious to health.

213 "Sore" means, when referring to an equine, that an irritating or blistering agent has been applied,  
214 internally or externally, by a person to any limb or foot of an equine; any burn, cut, or laceration that has been  
215 inflicted by a person to any limb or foot of an equine; any tack, nail, screw, or chemical agent that has been  
216 injected by a person into or used by a person on any limb or foot of an equine; any other substance or device  
217 that has been used by a person on any limb or foot of an equine; or a person has engaged in a practice  
218 involving an equine, and as a result of such application, infliction, injection, use, or practice, such equine  
219 suffers, or can reasonably be expected to suffer, physical pain or distress, inflammation, or lameness when  
220 walking, trotting, or otherwise moving, except that such term does not include such an application, infliction,  
221 injection, use, or practice in connection with the therapeutic treatment of an equine by or under the  
222 supervision of a licensed veterinarian. Notwithstanding anything contained herein to the contrary, nothing  
223 shall preclude the shoeing, use of pads, and use of action devices as permitted by 9 C.F.R. Part 11.2.

224 "Sterilize" or "sterilization" means a surgical or chemical procedure performed by a licensed veterinarian  
225 that renders a dog or cat permanently incapable of reproducing.

226 "Treasurer" includes the treasurer and his assistants of each county or city or other officer designated by  
227 law to collect taxes in such county or city.

228 "Treatment" or "adequate treatment" means the responsible handling or transportation of animals in the  
229 person's ownership, custody or charge, appropriate for the age, species, condition, size and type of the animal.

230 "Veterinary treatment" means treatment by or on the order of a duly licensed veterinarian.

231 "Weaned" means that an animal is capable of and physiologically accustomed to ingestion of solid food or  
232 food customary for the adult of the species and has ingested such food, without nursing, for a period of at  
233 least five days.

234 **§ 3.2-6504.2. Companion Animal Surgical Sterilization Fund.**

235 *There is hereby created in the state treasury a special nonreverting fund to be known as the Companion*  
236 *Animal Surgical Sterilization Fund, referred to in this section as "the Fund." The Fund shall be established*  
237 *on the books of the Comptroller. All pet food surcharges collected under § 58.1-1707.1 shall be paid into the*  
238 *state treasury and credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and*  
239 *be credited to it. Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year*  
240 *shall not revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for*  
241 *the purpose of paying the costs of surgical sterilizations of eligible animals and of presurgical examinations*  
242 *and vaccinations of companion animals eligible for surgical sterilization pursuant to § 3.2-6504.3.*

243 Expenditures and disbursements from the Fund shall be made by the State Treasurer on warrants issued by  
 244 the Comptroller upon written request signed by the Commissioner.

245 **§ 3.2-6504.3. Companion Animal Surgical Sterilization Program.**

246 A. An animal shall be eligible for surgical sterilization at no or reduced cost to its owner or caretaker if it  
 247 is (i) a companion animal that is in the possession of a releasing agency or a nonprofit organization, is not  
 248 owned by an individual, and such animal has not been transferred from a jurisdiction outside Virginia into  
 249 the Commonwealth; (ii) the companion animal of a low-income owner; or (iii) a feral or free-roaming cat.

250 B. The Department shall establish and administer the Companion Animal Surgical Sterilization Program  
 251 (the Program) and shall adopt regulations in support thereof. The Department shall work cooperatively with  
 252 other agencies of the Commonwealth, including the Department of Social Services and the Department of  
 253 Health, to facilitate the development of screening procedures for determining the eligibility of low-income  
 254 owners to participate in the Program. The Department shall screen companion animal owners and  
 255 caretakers of feral or free-roaming cats for eligibility in the Program, or contract for screening, to promote  
 256 the ease and convenience of applying for services under the Program. The Department shall promote the  
 257 Program to inform the public about companion animal overpopulation issues and surgical sterilization. The  
 258 Department shall prepare and submit to the Governor and the General Assembly no later than April 30 of  
 259 each year a report that describes and evaluates the Program's performance and impact over the previous  
 260 year and cumulatively since its inception.

261 **§ 3.2-6504.4. Participation by veterinarians in the Companion Animal Surgical Sterilization Program.**

262 A. Surgical sterilization services provided pursuant to § 3.2-6504.3 shall be performed only by  
 263 veterinarians licensed in the Commonwealth.

264 B. Any veterinarian, releasing agency, or nonprofit organization that provides surgical sterilizations of  
 265 companion animals is eligible to apply to the Department to participate in the Companion Animal Surgical  
 266 Sterilization Program (the Program) pursuant to § 3.2-6504.3. Each applicant shall submit an application  
 267 that includes a schedule listing the fees charged for companion animal sterilization in the applicant's normal  
 268 course of business. In addition to providing a schedule of fees, each releasing agency or nonprofit  
 269 organization shall provide documentation of its direct and indirect costs of performing surgical sterilization.

270 C. No participating surgical sterilization provider shall be required to (i) perform a medical procedure on  
 271 an animal that the provider determines is medically unfit, (ii) provide services to both dogs and cats, or (iii)  
 272 provide services to feral or free-roaming cats. No participating private veterinarian shall be required to  
 273 screen applicants for eligibility.

274 D. On a monthly basis, the Department shall pay from the Companion Animal Surgical Sterilization Fund  
 275 created in § 3.2-6504.2 each participating surgical sterilization provider for those surgical sterilizations,  
 276 presurgical examinations, and vaccinations that the Department has authorized for reimbursement as  
 277 follows:

278 1. A private veterinary surgical sterilization provider shall be entitled to reimbursement under its normal  
 279 fee schedule, provided that no such fee exceeds an amount that the Department determines is usual,  
 280 customary, and reasonable. The usual, customary, and reasonable fee limit shall be calculated at the  
 281 seventieth percentile rate, based upon the Department's review of prevailing fees for similar services charged  
 282 by peer private veterinary practices in the Commonwealth. The Department may establish rates of  
 283 compensation for presurgical examinations and for administration of vaccinations in such a manner and at a  
 284 level that the Department determines is fair and reasonable and shall evaluate and adjust rates of  
 285 compensation as warranted at two-year intervals.

286 2. The Department shall establish separate rates of compensation for the reasonable costs of surgical  
 287 sterilization provided by releasing agencies and nonprofit organizations that are participating surgical  
 288 sterilization providers. Compensation provided under this section shall not exceed the fee limit established  
 289 for private veterinary practices. The Department shall evaluate and adjust rates of compensation as  
 290 warranted at two-year intervals.

291 E. To receive reimbursement for surgical sterilizations and other approved services, the participating  
 292 surgical sterilization provider shall submit documentation of authorized services performed as required by  
 293 the Department. The Department shall not reimburse a provider for any services not authorized for payment.

294 F. A participating surgical sterilization provider may charge a low-income owner of a dog or cat a  
 295 copayment that shall not exceed \$20 per dog and \$10 per cat. No copayment shall be charged for a surgical  
 296 sterilization performed on a feral or free-roaming cat. Owners of companion animals and caretakers of feral  
 297 or free-roaming cats are responsible for payment of any additional fees due to the participating surgical  
 298 sterilization provider that are mutually agreed upon, administered by that provider, and not covered under  
 299 the Program.

300 **§ 58.1-1707.1. Pet food surcharge.**

301 There is hereby levied and imposed upon every person in the Commonwealth engaged in business as a  
 302 manufacturer, wholesaler, or distributor of pet food products an annual Companion Animal Surgical  
 303 Sterilization Fund surcharge of \$50 for each ton of pet food distributed, to be paid into the state treasury and

304 *credited to the Companion Animal Surgical Sterilization Fund as specified in § 3.2-6504.2.*

305 **§ 58.1-1708. Products.**

306 Manufacturers, wholesalers, distributors, or retailers of the following products shall be subject to the tax  
307 imposed in § 58.1-1707:

- 308 1. Food for human ~~or~~ pet consumption;
- 309 2. Groceries;
- 310 3. Cigarettes and tobacco products;
- 311 4. Soft drinks and carbonated waters;
- 312 5. Beer and other malt beverages;
- 313 6. Wine;
- 314 7. Newspapers and magazines;
- 315 8. Paper products and household paper;
- 316 9. Glass containers;
- 317 10. Metal containers;
- 318 11. Plastic or fiber containers made of synthetic material;
- 319 12. Cleaning agents and toiletries;
- 320 13. Nondrug drugstore sundry products;
- 321 14. Distilled spirits; and
- 322 15. Motor vehicle parts.
