11	Be it enacted by the General Assembly of Virginia:
12	1. That § 28.2-314 of the Code of Virginia is amended and reenacted as follows:
13	§ 28.2-314. Trawl nets and drag nets prohibited; exception; license fee; penalty.
14	Except as may be provided in § 28.2-315, it A. It is unlawful for any person (i) to take or catch fish,
15	shellfish, or marine organisms with a trawl net, drag net, or similar device drawn through the waters by a
16	vessel, boat, or other craft or (ii) to buy, sell, or offer for sale any fish taken or caught in the waters of the
17	Commonwealth, or under the jurisdiction of the Commonwealth, with a trawl net, drag net, or similar device.
18	However, the Commission may issue licenses or permits to take or catch fish, shellfish, or marine organisms
19	with a trawl net, drag net, or similar device within the three-mile limit of the Virginia Atlantic shoreline for
20	the shrimp and horseshoe crab fisheries.
