That the Code of Virginia is amended by adding a section numbered 22.1-207.4:3 as follows: 14 § 22.1-207.4:3. Nutritional standards for school meals and other foods; certain color additives 15 prohibited. 16 A. As used in this section: "Color additive" means any material not exempted pursuant to 21 U.S.C. § 321(t)(1) that is a dye, 17 18 pigment, or other substance made by a process of synthesis or similar artifice, or extracted, isolated, or 19 otherwise derived, with or without intermediate or final change of identity, from a vegetable, animal, 20 mineral, or other source and that when added or applied to a food, drug, or cosmetic, or to the human body or any part thereof, is capable of imparting color thereto. 21 22 "Competitive food" means the same as that term is defined in § 22.1-207.4. 23 B. No public elementary or secondary school shall offer or make available to any student any food served 24 as a part of a school meal or any competitive food that contains any of the following color additives: 25 1. FD&C Blue No. 1 (CAS Reg. No. 3844-45-8); 26 2. FD&C Blue No. 2 (CAS Reg. No. 860-22-0); 27 3. FD&C Green No. 3 (CAS Reg. No. 2353-45-9); 28 4. FD&C Red No. 3 (CAS Reg. No. 16423-68-0); 29 5. FD&C Red No. 40 (CAS Reg. No. 25956-17-6); **30** 6. FD&C Yellow No. 5 (CAS Reg. No. 1934-21-0); or 7. FD&C Yellow No. 6 (CAS Reg. No. 2783-94-0). 31 C. The Board shall amend its nutritional guidelines for competitive foods promulgated pursuant to § 22.1-207.4 in accordance with the provisions of this section.
