73 presiding officers of each house shall appoint a committee of three, which together shall constitute the joint  
74 committee to count the vote of each house in each case and report the results to their respective houses. The  
75 joint order may be suspended by the presiding officer of either house at any time but for no longer than  
76 twenty-four hours to receive the report of the joint committee.
