Bill Number:SB1003Patron:RoemBill Title:School breakfasts; availability at no cost to students.

Bill Summary: Requires each school board to require each public elementary and secondary school in the local school division to participate in the federal National School Lunch Program and the federal School Breakfast Program administered by the U.S. Department of Agriculture and to make breakfast available to any student who requests such a meal at no cost to the student, unless the student's parent has provided written permission to the school board to withhold such a meal from the student. The bill requires the Department of Education to reimburse each public elementary and secondary school for each school breakfast served to a student, with a maximum of one breakfast per student per school day and provides the formula for determining the state reimbursement rate for such meals. Finally, the bill repeals a provision of law relating to the federal School Breakfast Program that is rendered obsolete by the provisions of the bill.

Budget Amendment Necessary:YesItems Impacted:120, 125Explanation:This bill directs the state to reimburse local school divisions for each school breakfast
served, which would require additional funding through Direct Aid to Public Education.
Amendments also may be required to eliminate or modify existing state-supported school
breakfast programs. Additionally, the Department of Education (DOE) would require
additional funding and an additional position to implement the provisions of this bill. Any
impact to local school divisions is indeterminate.

Fiscal Summary: The Department of Education estimates an additional state cost of at least \$29,022,624 general fund per year beginning in FY26 to reimburse for school breakfasts as required by this bill; however, this cost assumes that the existing Direct Aid programs that provide state support for school breakfasts are eliminated or reduced and those funds are redirected to this initiative, as explained under the Fiscal Analysis. Additionally, DOE estimates one-time costs of \$25,000 and ongoing costs of \$140,952 to implement the provisions of this bill.

Fiscal Analysis: This bill directs each local school division to make school breakfast available pursuant to the federal School Breakfast Program to any student who requests a school breakfast at no cost to the student. The bill directs that the state shall reimburse each school for each school breakfast served at an amount equal to the difference between the amount paid by the U.S. Department of Agriculture and the free rate. For the 2024-2025 school year the difference between the federally set paid and free rates is \$2.45.

In the 2023-2024 school year 65.3 million school breakfasts were served in Virginia public schools, including 13.1 million paid meals. Based on data from other states and Community Eligibility Provision (CEP) implementation in Virginia, it is likely that the implementation of free breakfast will lead to an increase in the number of breakfasts served. In order to estimate the cost of providing free breakfast for all students, DOE assumed that the number of breakfasts served at CEP participating schools would remain constant but would increase by 23% at schools not participating or not eligible for CEP. Based on the current reimbursement rate and the growth assumptions, DOE estimates a base additional state cost of \$40,311,705 annually beginning in FY26.

State funding is currently provided for school breakfasts through three programs under Direct Aid to Public Education. Item 125 of the Governor's Introduced budget, HB1600/SB800, provides in FY26 \$9,915,081 lottery funds for the existing School Breakfast Program, \$1,074,000 general fund for the Breakfast After the Bell Initiative, and \$4,100,000 general fund for School Meals Expansions. If free school breakfasts are fully funded through this new program, then the entire appropriation for the existing School Breakfast Program and the Breakfast after the Bell Initiative, and an estimated \$300,000 of the School Meals Expansion will no longer be necessary and can be redirected to free school breakfasts for all. These savings would make the additional state cost \$29,022,624 general fund annually beginning in FY26.

The actual state fiscal impact is indeterminate and would depend on the actual number of meals served and the rates set by the federal government in future years. Any impact to local school divisions is indeterminate.

The Department of Education would also require additional funding in order to implement the provisions of this bill. DOE's software system that is used for processing school meals reimbursement would need to be enhanced in order to handle this larger reimbursement program, and DOE estimates \$25,000 in one-time costs for system upgrades. DOE also anticipates the need for an additional position in the Office of School Nutrition to administer the program at a total cost of \$140,952, including salary, benefit and technology costs. This assumes for \$85,000 for salary, \$45,952 for benefits, and \$10,000 for technology and travel assistance.

Other: This bill is identical to HB1958 as introduced.
