# **Estimate of Local Fiscal Impact**

2025 General Assembly Session | 1/16/25

In accordance with the provisions of 30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of legislation impacting local governments.

HB2000: Dam Safety Act; powers and duties of DCR, rights and requirements of dam owners, civil penalty. (Patron: Amy J. Laufer)

Bill Summary: Dam Safety, Flood Prevention and Protection Assistance; Dam Safety Act; powers and duties of the Department of Conservation and Recreation; rights and requirements of dam owners; civil penalty. Amends various provisions of the Dam Safety Act to streamline the Department of Conservation and Recreation's enforcement powers for impounding structures under the Act and clarifies the Department's powers and duties during an active dam failure. The bill also makes changes to a dam owner's responsibilities under the Act, including adding additional requirements to obtain a general permit for a low hazard impounding structure, making a dam owner responsible for ensuring that his impounding structure that presents an imminent danger has a safety inspection performed as provided in the bill, and allowing a dam owner to identify the dam break inundation zone of his impounding structure by providing the limits of the dam break inundation zone in lieu of filing a map. The bill also changes certain criteria for applicants to receive funds from the Dam Safety, Flood Prevention and Protection Assistance Fund, including the project match requirements for grants or loans. Finally, the bill repeals the provisions providing civil penalties for violating the provisions of the Act.

Summary Analysis:		

Number of Localities Responding: 5 Cities, 11 Counties, 3 Towns, 1 Other

Localities estimated a negative fiscal impact ranging from \$20,000 to \$35.5 million over the biennium.

Localities that contain dams identified the fiscal impact as including capital costs (materials, equipment, and contracting of specialized services), personnel costs (compensation for engineers, construction managers, laborers, and other specialists, as well as administrative costs related to permitting, site preparation, and environmental mitigation), recurring costs (monitoring and inspections of sites, maintenance, and emergency response plans), as well as additional capital investment and maintenance of capital equipment. Albemarle County expressed concern that Section 10.1-608 of this bill compels localities to essentially act as an agent of DCR during potential dam emergencies and would likely result in costs to the County without any language about cost recovery for localities.

	Many of the proposed amendments in House Bill 2000 to dam safety regulations are relatively inconsequential clarifications.
	However, the one area of concern the County has is in Section 10.1-608. Unsafe dam presenting imminent danger. Proposed
	language compels localities to essentially act as an agent of DCR during potential dam emergencies and would likely result in
	costs to the County. The dam safety regulations already include language about the Commonwealth recovering expenses from
	the dam owner but there is no such language suggesting that cost recovery would be shared with localities. The occasional
	resulting costs to the County from this legislation are not easily calculated, but are estimated at \$10,000 per year. Years with
	more severe emergencies would result in higher annual costs to the County, which could be offset by years with less severe
	emergencies. It is preferred it the legislation were amended to include alternative language that would invite or enable locality
Albemarle County	participation during emergencies but not obligate them to do so.

Bedford County	No fiscal impact expected to Bedford County related to this bill.
Charlotte County	The County does not own any impoundments or dams.
	The projected fiscal impact on Chesterfield County concerning HB2000 amounts to over \$35 million. High hazard private dams
	across the County will be subject to state standards, which if directed by the Director of DCR, the County will be responsible for
	repairs. Capital costs include materials, equipment, and contracting of specialized services for each dam. Personnel costs include
	compensation for engineers, construction managers, laborers, and other specialists, as well as administrative costs related to
	permitting, site preparation, and environmental mitigation. Recurring costs include monitoring and inspections of sites,
	maintenance, and emergency response plans, as well as additional capital investment and maintenance of capital equipment.
	This policy may introduce a moral hazard where private dam owners, aware of the possibility the County will fund dam repairs,
Chesterfield County	will be reluctant to carefully manage and maintain the dam and encourage poor management.
	Since there are no dams in Alexandria, there is no identified fiscal impact as a result of the proposed legislation for the City of
