## **Estimate of Local Fiscal Impact**

2025 General Assembly Session | 1/22/25

In accordance with the provisions of 30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of legislation impacting local governments.

## HB2377: Comprehensive plan; data centers; water usage. (M. Keith Hodges)

**Bill Summary:** Comprehensive plan; data centers; water usage. Requires every locality to incorporate into its comprehensive plan provisions that prioritize and evaluate alternative methods of cooling, such as air cooling, geothermal cooling, or other innovative technologies that minimize water usage, particularly in the context of approving or siting data centers or similar land uses. The bill provides that the comprehensive plan shall include methods of assessing the environmental impact of water-based cooling methods and requires that alternative methods to minimize water usage are thoroughly considered before local approval of data centers or similar land uses that are reliant on significant water resources for cooling purposes.

Locality	Expenditure Narrative by Responding Localities
Albemarle County	The proposed bill requires the County to include certain considerations in its Comprehensive Plan. Any updates to the Comprehensive Plan carry associated costs. Ultimately, the final cost is dependent on how detailed and thorough the County desires to be throughout the process of updating the Plan. Using existing staff and largely copying what other localities have done would result in minimal costs, while hiring a consultant and implementing an extensive public participation program would result in much higher costs. The County opposes this bill as it places an additional requirement upon the County and because the County already has the legal authority to do what this bill seeks to require.

Bedford County	County does not permitting and zoning ordinance do not allow data centers.
	The county anticipates a minimal fiscal impact. The requirement for a thorough evaluation of diverse water use technologies
	may require third party consulting to evaluate environmental impacts; the cost impact of any third party analysis will depend on
Chesterfield County	the scope and frequency of analysis.
	This legislation would increase Alexandria's responsibilities for the next Comprehensive Plan update, which could have
	considerable staffing fiscal impact. Alexandria's zoning ordinance and non-residential land market does not create an
	environment where data centers are likely to be proposed, so this legislation requiring adding this element into the City's
City of Alexandria	comprehensive plan would probably not be needed.
City of Norfolk	As written, the legislation will not have significant fiscal impact.
City of Richmond	No anticipated fiscal impact.

	This bill would require at least one Comprehensive Plan Amendment (perhaps more depending on our approach).
	My initial thoughts are (1) that the Comprehensive Plan is not the appropriate place for this type of language, and (2) our
	Ordinance already requires cooling technology which minimizes water usage; adding the suggested information to our Comp
Fauquier County	Plan would be counterintuitive.

	There is no cost associated with this bill only because our next Comprehensive Plan review is outside of the two-year budget
	window called for by these bill analyses. If our Plan revision was in the two-year window, there would be cost associated with
	this bill, but it is indeterminate. It would be an additional scope of work on an already expensive project (our last plan revision
	cost \$120,000 as is). Additionally, I am not convinced that the traditional planner skill set that performs Comprehensive Plans
	have the capabilities or technical knowhow to produce the reviews called for in this bill. I would encourage this bill to be
	amended to instruct one of Virginia's universities to create a program in these areas, which could then provide technical
	assistance to localities. Ideally, this program would have some combination of engineers, data scientists, and environmental
