WHEREAS, consideration of the location of potential infrastructure is needed to ensure such proposed route would not impact Jamestown or any other historical assets in the Commonwealth; now, therefore, be it

requested to study the need and options for constructing a bridge from Surry County to James City County or

study, the Department of Transportation shall (i) survey and identify potential locations for constructing a bridge over the James River from Surry County to either James City County or Charles City County and

evaluate the potential environmental impacts and any technical considerations associated with each identified

location to provide a recommendation of the most suitable locations for the construction of a bridge; (ii)

evaluate the benefit such bridge would provide to Surry County, James City County, Charles City County, and the entire region, including the impact on safety, by providing an additional route for evacuation in the

event of flooding or major storms, allowing faster responses by emergency services, and relieving traffic

congestion; (iii) develop cost estimates for the erection and maintenance of a bridge for each identified

potential crossing site and determine the estimated length of time for project completion for each potential

crossing location; and (iv) evaluate possible funding options for the construction of a bridge spanning from

The executive summary and report shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports no later than the first day of the 2026 Regular Session of the General Assembly and shall be posted on the General Assembly's website.
