6	A BILL to amend and reenact § 22.1-272.1:1 of the Code of Virginia, relating to Board of Education;
7	school-connected overdoses; policies relating to parental notification and response; requirements.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 22.1-272.1:1 of the Code of Virginia is amended and reenacted as follows:
10	§ 22.1-272.1:1. School-connected overdoses; response and prevention; parental notification;
11	requirements.
12	A. As used in this section:
13	"Overdose" means a life-threatening condition resulting from the consumption or use of a controlled
14	substance, alcohol, or any combination of such substances.
15	"School-connected overdose" includes any verified overdose that (i) occurs on school premises during or
16	after regular school hours or (ii) occurs during school-sanctioned activities whether on or off school
17	premises.
18	B. Each division superintendent or his designee shall notify the parent of each student in the local school
19	division of any suspected school-connected overdose within 24 hours of learning of the suspected overdose.
20	The parental notification shall include as much information as is available on:
21	1. The cause of the suspected overdose, including the name of the drug and any common street names
22	associated with the drug that caused the overdose; whether the drug was a combination of controlled
23	substances and, if so, the name of those controlled substances; and any identifying features of the drug,
24	including color, markings, and form;
25	2. Where the suspected overdose occurred and, if such overdose occurred on school premises, the name of
26	the school at which the suspected overdose occurred; and
27	3. The immediate response to the suspected overdose by any emergency responders and employees of the
28	local school board.
29	C. The Board shall establish guidelines for school-connected overdose response and parental notification

30 policies to aid local school boards in the implementation of such policies. The guidelines shall include (i) a

31 model action plan for each school board to follow in responding to any school-connected overdose, including 32 communicating and coordinating with (a) the Department and (b) the applicable law-enforcement liaison or 33 the local law-enforcement agency that, pursuant to § 22.1-280.2:3, employs such school division's school 34 resources officers, and (ii) criteria for issuing *the* parental notification *pursuant to subsection B* to ensure 35 sensitivity to the privacy interests of affected individuals and compliance with any applicable law, rules, or 36 regulations relating to the disclosure and protection of a minor's personal, confidential, or otherwise sensitive 37 information.

**38** *D. Each school board shall adopt, implement, and maintain policies consistent with subsection B and the* 

*39* guidelines developed by the Board pursuant to subsection C.
