A BILL to amend and reenact § 2.2-4310 of the Code of Virginia, relating to Virginia Public Procurement Act; discrimination prohibited; military family-owned businesses.  
on \_\_\_\_\_)

Be it enacted by the General Assembly of Virginia:

1. That § 2.2-4310 of the Code of Virginia is amended and reenacted as follows:

§ 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, military family-owned, and service disabled veteran-owned businesses and employment services organizations.

A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or offeror because of race, religion, color, sex, sexual orientation, gender identity, national origin, age, disability, status as a service disabled veteran, *status as a military family*, or any other basis prohibited by state law relating to discrimination in employment. Whenever solicitations are made, each public body shall include businesses selected from a list made available by the Department of Small Business and Supplier Diversity, which list shall include all companies and organizations certified by the Department.

B. All public bodies shall establish programs consistent with this chapter to facilitate the participation of small businesses, businesses owned by women, minorities, and service disabled veterans, *military family-owned businesses*, and employment services organizations in procurement transactions. The programs established shall be in writing and shall comply with the provisions of any enhancement or remedial measures authorized by the Governor pursuant to subsection C or, where applicable, by the chief executive of a local governing body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. State agencies shall submit annual progress reports on (i) small, women-owned, and minority-owned business procurement; (ii) service disabled veteran-owned business procurement; (iii) *military family-owned business procurement*; and ~~(iii)~~ (iv) employment services organization procurement to the Department of Small Business and Supplier Diversity in a form specified by the Department of Small Business and Supplier Diversity. All state agencies shall cooperate with the Department of Small Business and Supplier Diversity's annual review of their programs pursuant to § 2.2-1605 and shall update such programs to incorporate any feedback and suggestions for improvement. Contracts and subcontracts awarded to employment services organizations and service disabled veteran-owned *or military family-owned* businesses shall be credited toward the small business, women-owned, and minority-owned business contracting and subcontracting goals of state agencies and contractors. The Department of Small Business and Supplier Diversity shall make information on service disabled veteran-owned *or military family-owned* procurement available to the Department of Veterans Services upon request.

C. Whenever there exists (i) a rational basis for small business or employment services organization enhancement or (ii) a persuasive analysis that documents a statistically significant disparity between the availability and utilization of women-owned and minority-owned businesses, the Governor is authorized and encouraged to require state agencies to implement appropriate enhancement or remedial measures consistent with prevailing law. Any enhancement or remedial measure authorized by the Governor pursuant to this subsection for state public bodies may allow for small businesses certified by the Department of Small Business and Supplier Diversity or a subcategory of small businesses established as a part of the enhancement program to have a price preference over noncertified businesses competing for the same contract award on designated procurements, provided that the bid of the certified small business or the business in such subcategory of small businesses established as a part of an enhancement program does not exceed the low bid by more than five percent.

D. In awarding a contract for services to a small, women-owned, or minority-owned business that is certified in accordance with § 2.2-1606, or to a business identified by a public body as a service disabled veteran-owned *or military family-owned* business where the award is being made pursuant to an enhancement or remedial program as provided in subsection C, the public body shall include in every such contract of more than \$10,000 the following:

"If the contractor intends to subcontract work as part of its performance under this contract, the contractor shall include in the proposal a plan to subcontract to small, women-owned, minority-owned, and service disabled veteran-owned *and military family-owned* businesses."

E. In the solicitation or awarding of contracts, no state agency, department, or institution shall discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the state agency, department, or institution has made a written determination that employing ex-offenders on the

61 F. As used in this section:

62 "Employment services organization" means an organization that provides community-based employment  
63 services to individuals with disabilities that is an approved Commission on Accreditation of Rehabilitation  
64 Facilities (CARF) accredited vendor of the Department for Aging and Rehabilitative Services.

65 "*Military family*" means (i) a member of the uniformed forces, as defined in 10 U.S.C. § 101(a)(5), of the  
66 United States or a reserve component thereof named under 10 U.S.C. § 10101, (ii) a veteran as defined in 38  
67 U.S.C. § 101(2), or (iii) a dependent as defined in 50 U.S.C. § 3911(4) except that the support provided by  
68 the service member to the individual shall have been provided 180 days immediately preceding an alleged  
69 action that if proven true would constitute unlawful discrimination under this section instead of 180 days  
70 immediately preceding an application for relief under 50 U.S.C. Chapter 50.

71 "*Military family-owned business*" means a business that is at least 51 percent owned by one or more  
72 persons within the definition of "military family" or, in the case of a corporation, partnership, or limited  
73 liability company or other entity, in which at least 51 percent of the equity ownership interest in the  
74 corporation, partnership, or limited liability company or other entity is owned by one or more individuals  
75 who are persons within the definition of "military family" and both the management and daily business  
76 operations are controlled by one or more individuals who are persons within the definition of "military family"  
77 .

78 "Minority individual" means an individual who is a citizen of the United States or a legal resident alien  
79 and who satisfies one or more of the following definitions:

80 1. "African American" means a person having origins in any of the original peoples of Africa and who is  
81 regarded as such by the community of which this person claims to be a part.

82 2. "Asian American" means a person having origins in any of the original peoples of the Far East,  
83 Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China,  
84 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of the  
85 Pacific, India, Pakistan, Bangladesh, or Sri Lanka and who is regarded as such by the community of which  
86 this person claims to be a part.

87 3. "Hispanic American" means a person having origins in any of the Spanish-speaking peoples of Mexico,  
88 South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and who is  
89 regarded as such by the community of which this person claims to be a part.

90 4. "Native American" means a person having origins in any of the original peoples of North America and  
91 who is regarded as such by the community of which this person claims to be a part or who is recognized by a  
92 tribal organization.

93 "Minority-owned business" means a business that is at least 51 percent owned by one or more minority  
94 individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or  
95 limited liability company or other entity, at least 51 percent of the equity ownership interest in the  
96 corporation, partnership, or limited liability company or other entity is owned by one or more minority  
97 individuals who are U.S. citizens or legal resident aliens, and both the management and daily business  
98 operations are controlled by one or more minority individuals, or any historically black college or university  
99 as defined in § 2.2-1604, regardless of the percentage ownership by minority individuals or, in the case of a  
100 corporation, partnership, or limited liability company or other entity, the equity ownership interest in the  
101 corporation, partnership, or limited liability company or other entity.

102 "Service disabled veteran" means a veteran who (i) served on active duty in the United States military  
103 ground, naval, or air service, (ii) was discharged or released under conditions other than dishonorable, and  
104 (iii) has a service-connected disability rating fixed by the United States Department of Veterans Affairs.

105 "Service disabled veteran business" means a business that is at least 51 percent owned by one or more  
106 service disabled veterans or, in the case of a corporation, partnership, or limited liability company or other  
107 entity, at least 51 percent of the equity ownership interest in the corporation, partnership, or limited liability  
108 company or other entity is owned by one or more individuals who are service disabled veterans and both the  
109 management and daily business operations are controlled by one or more individuals who are service disabled  
110 veterans.

111 "Small business" means a business, independently owned and controlled by one or more individuals, or in  
112 the case of a cooperative association organized pursuant to Chapter 3 (§ 13.1-301 et seq.) of Title 13.1 as a  
113 nonstock corporation, controlled by one or more members, who are U.S. citizens or legal resident aliens, and  
114 together with affiliates, has 250 or fewer employees, or annual gross receipts of \$10 million or less averaged  
115 over the previous three years. One or more of the individual owners or members shall control both the  
116 management and daily business operations of the small business.

117 "State agency" means any authority, board, department, instrumentality, institution, agency, or other unit  
118 of state government. "State agency" shall not include any county, city, or town.

119 "Women-owned business" means a business that is at least 51 percent owned by one or more women who  
120 are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited liability

**121** company or other entity, at least 51 percent of the equity ownership interest is owned by one or more women  
**122** who are U.S. citizens or legal resident aliens, and both the management and daily business operations are  
**123** controlled by one or more women.
