WHEREAS, Charles C. Pace, an honorable veteran, esteemed educator and public servant, and beloved father and member of the Charlottesville community, died on December 18, 2024; and

WHEREAS, born in Hampton, Charles "Chuck" C. Pace graduated from Charlottesville High School in 1978 before earning a degree from the Virginia Military Institute in 1982 and serving his country with honor and distinction as a member of the United States Navy; and

WHEREAS, following his service, Chuck Pace discovered his life's purpose when he began teaching at Blue Ridge School in Saint George; he would go on to teach biology and chemistry at Albemarle High School for many years and to serve as the science instructional coordinator for Albemarle County Public Schools for 11 years before returning to Blue Ridge School, where he retired in 2022; and

WHEREAS, over his remarkable 39-year career as an educator and coach, Chuck Pace worked tirelessly
to support his students and fellow faculty, contributing greatly to their success both in and out of the
classroom; and
WHEREAS, from 1982 to 2001, Chuck Pace contributed to the safety and security of the nation as an
