6	A BILL to amend the Code of Virginia by adding a section numbered 32.1-174.5, relating to Department of		
7	Health Office of Drinking Water; waterworks; mandatory reporting; monthly operation report.		
8	Be it enacted by the General Assembly of Virginia:		
9	1. That the Code of Virginia is amended by adding a section numbered 32.1-174.5 as follows:		
10	§ 32.1-174.5. Mandatory reporting of contaminant releases and equipment failures and malfunctions.		
11	A. As used in this section:		
12	"Contaminant release" means an unplanned or uncontrolled release by a waterworks of a chemical		
13	contaminant or petroleum or synthetic oil into the water that is treated by or distributed from the waterworks		
14	to customers. "Contaminant release" includes any such release at treatment facilities and raw or finished		
15	water pump stations.		
16	"Critical equipment failure or malfunction" means any equipment failure or malfunction that has		
17	significant potential for serious adverse effects on human health as a result of short-term exposure or to		
18	cause a widespread disruption of water service.		
19	"Equipment failure" means an unplanned condition when the equipment cannot perform or is unable to		
20	perform as designed because of a problem with such equipment. "Equipment failure" does not mean a		
21	planned (i) removal from service, (ii) repair, or (iii) maintenance.		
22	"Equipment malfunction" means an unplanned condition during which the equipment cannot perform or		
23	is unable to perform as designed due to a problem originating from outside the waterworks rather than a		
24	problem associated or originating with the equipment itself, including an issue with third-party provided gas		
25	or electric power feeds or a cyberattack.		
26	"Monthly operating report" means the report submitted by a waterworks to the Office at least once each		
27	month that describes the waterworks' operational status and compliance with applicable laws, regulations,		
28	and policies, as directed by the Department.		
29	"Noncritical equipment failure or malfunction" means an equipment failure or malfunction that is not a

critical equipment failure or malfunction, regardless of whether such anomaly is noticeable to customers of

- "Office" means the Department's Office of Drinking Water.
- B. The owner of a waterworks shall report any critical equipment failure or malfunction or contaminant
- release to the Office as soon as practicable but no more than six hours after discovery.
- 35 C. Any owner of a waterworks that is required to submit a monthly operating report to the Office shall
- 36 include any noncritical equipment failure or malfunction that could adversely affect water quality, public
- 37 health, or service continuity that occurred during the applicable reporting month and was not resolved by the
- 38 reporting deadline. For the purposes of this subsection, any noncritical equipment failure or malfunction that
- 39 is effectively addressed by equipment repair or replacement, alternative equipment use, alternative system
- 40 operation, or such other response shall be considered resolved.
