11	1. That the Code of Virginia is amended by adding sections numbered 15.2-2223.6, 15.2-2292.3, and

13	§ 15.2-2223.6. Comprehensive plan; housing development by nonprofit organizations.
14	Beginning July 1, 2025, a locality shall, during the next scheduled and all subsequent reviews of its
15	comprehensive plan as required in § 15.2-2230, incorporate, based on community input, into its
16	comprehensive plan strategies to support affordable housing development by property tax-exempt nonprofit
17	organizations.
18	§ 15.2-2292.3. Waiver of certain requirements; nonprofit organizations.
19	A. For the purposes of this section, "affordable housing" means the same as that term is defined in §
20	15.2-2201.
21	B. To stimulate the development, redevelopment, or use of real property owned by entities classified as
22	property tax-exempt nonprofit organizations as described in § 58.1-3609 for affordable housing, any locality
23	may provide by ordinance (i) the alteration or waiver of requirements for zoning permits related to
24	administrative fees, residential density, height, or lot size and (ii) the creation of site plan application
25	incentives, such as expedited approval or modification of fees.
26	C. If a locality adopts an ordinance pursuant to subsection B, such ordinance shall ensure that any
27	property tax-exempt nonprofit organization seeking to develop, redevelop, or use its real property for
28	affordable housing shall preserve the affordable housing for at least 40 years.
29	§ 36-139.9:1. Housing development by nonprofit organization.

The Department shall develop a document describing strategies that a locality may consider when

31	implementing an ordinance to stimulate affordable housing on property owned by a property tax-exemp
32	nonprofit organization in accordance with § 15.2-2292.3. The Department shall consult stakeholders
33	including local governments, nonprofit organizations, and other expert resources as determined by the
34	Department, to develop such strategies. Such document shall be published on the Department's website no
35	later than December 1, 2025, and updated every five years thereafter.
