2 *An Act to amend and reenact § 18.2-308.2:2 of the Code of Virginia, relating to assault firearms; purchase;*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 18.2-308.2:2 of the Code of Virginia is amended and reenacted as follows:**8 **§ 18.2-308.2:2. Criminal history record information check required for the transfer of certain**
 9 **firearms.**

10 A. Any person purchasing from a dealer a firearm as herein defined shall consent in writing, on a form to
 11 be provided by the Department of State Police, to have the dealer obtain criminal history record information,
 12 *and if such firearm is an assault firearm as defined in this section, such person purchasing such assault*
 13 *firearm shall be 21 years of age or older.* Such form shall include only the written consent; the name, birth
 14 date, gender, race, citizenship, and social security number and/or any other identification number; the number
 15 of firearms by category intended to be sold, rented, traded, or transferred; and answers by the applicant to the
 16 following questions: (i) has the applicant been convicted of a felony offense or a misdemeanor offense listed
 17 in § 18.2-308.1:8 or found guilty or adjudicated delinquent as a juvenile 14 years of age or older at the time
 18 of the offense of a delinquent act that if committed by an adult would be a felony or a misdemeanor listed in
 19 § 18.2-308.1:8; (ii) is the applicant subject to a court order restraining the applicant from harassing, stalking,
 20 or threatening the applicant's child or intimate partner, or a child of such partner, or is the applicant subject to
 21 a protective order; (iii) has the applicant ever been acquitted by reason of insanity and prohibited from
 22 purchasing, possessing, or transporting a firearm pursuant to § 18.2-308.1:1 or any substantially similar law
 23 of any other jurisdiction, been adjudicated legally incompetent, mentally incapacitated, or adjudicated an
 24 incapacitated person and prohibited from purchasing a firearm pursuant to § 18.2-308.1:2 or any substantially
 25 similar law of any other jurisdiction, been involuntarily admitted to an inpatient facility or involuntarily
 26 ordered to outpatient mental health treatment and prohibited from purchasing a firearm pursuant to §
 27 18.2-308.1:3 or any substantially similar law of any other jurisdiction, or been the subject of a temporary
 28 detention order pursuant to § 37.2-809 and subsequently agreed to a voluntary admission pursuant to §
 29 37.2-805; and (iv) is the applicant subject to an emergency substantial risk order or a substantial risk order
 30 entered pursuant to § 19.2-152.13 or 19.2-152.14 and prohibited from purchasing, possessing, or transporting
 31 a firearm pursuant to § 18.2-308.1:6 or any substantially similar law of any other jurisdiction.

32 B. 1. No dealer shall sell, rent, trade, or transfer from his inventory any such firearm to any other person
 33 who is a resident of Virginia until he has (i) obtained written consent and the other information on the consent
 34 form specified in subsection A, and provided the Department of State Police with the name, birth date,
 35 gender, race, citizenship, and social security and/or any other identification number and the number of
 36 firearms by category intended to be sold, rented, traded, or transferred ~~and~~; (ii) requested criminal history
 37 record information by a telephone call to or other communication authorized by the State Police and is
 38 authorized by subdivision 2 to complete the sale or other such transfer; *and (iii) if such firearm is an assault*
 39 *firearm, verified that such person is 21 years of age or older.* To establish personal identification and
 40 residence in Virginia for purposes of this section, a dealer must require any prospective purchaser to present
 41 one photo-identification form issued by a governmental agency of the Commonwealth or by the United States
 42 Department of Defense or a special identification card without a photograph issued pursuant to § 46.2-345.2
 43 that demonstrates that the prospective purchaser resides in Virginia. For the purposes of this section and
 44 establishment of residency for firearm purchase, residency of a member of the armed forces shall include
 45 both the state in which the member's permanent duty post is located and any nearby state in which the
 46 member resides and from which he commutes to the permanent duty post. A member of the armed forces
 47 whose photo identification issued by the Department of Defense does not have a Virginia address may
 48 establish his Virginia residency with such photo identification and either permanent orders assigning the
 49 purchaser to a duty post, including the Pentagon, in Virginia or the purchaser's Leave and Earnings
 50 Statement. When the identification presented to a dealer by the prospective purchaser is a driver's license or
 51 other photo identification issued by the Department of Motor Vehicles or a special identification card without
 52 a photograph issued pursuant to § 46.2-345.2, and such identification form or card contains a date of issue,
 53 the dealer shall not, except for a renewed driver's license or other photo identification issued by the
 54 Department of Motor Vehicles or a renewed special identification card without a photograph issued pursuant
 55 to § 46.2-345.2, sell or otherwise transfer a firearm to the prospective purchaser until 30 days after the date of
 56 issue of an original or duplicate driver's license or special identification card without a photograph unless the

57 prospective purchaser also presents a copy of his Virginia Department of Motor Vehicles driver's record
58 showing that the original date of issue of the driver's license was more than 30 days prior to the attempted
59 purchase.

60 In addition, no dealer shall sell, rent, trade, or transfer from his inventory any assault firearm to any
61 person who is not a citizen of the United States or who is not a person lawfully admitted for permanent
62 residence.

63 Upon receipt of the request for a criminal history record information check, the State Police shall (a)
64 review its criminal history record information to determine if the buyer or transferee is prohibited from
65 possessing or transporting a firearm by state or federal law, (b) inform the dealer if its record indicates that
66 the buyer or transferee is so prohibited, and (c) provide the dealer with a unique reference number for that
67 inquiry.

68 2. The State Police shall provide its response to the requesting dealer during the dealer's request or by
69 return call without delay. A dealer who fulfills the requirements of subdivision 1 and is told by the State
70 Police that a response will not be available by the end of the dealer's fifth business day may immediately
71 complete the sale or transfer and shall not be deemed in violation of this section with respect to such sale or
72 transfer.

73 3. Except as required by subsection D of § 9.1-132, the State Police shall not maintain records longer than
74 30 days, except for multiple handgun transactions for which records shall be maintained for 12 months, from
75 any dealer's request for a criminal history record information check pertaining to a buyer or transferee who is
76 not found to be prohibited from possessing and transporting a firearm under state or federal law. However,
77 the log on requests made may be maintained for a period of 12 months, and such log shall consist of the name
78 of the purchaser, the dealer identification number, the unique approval number, and the transaction date.

79 4. On the last day of the week following the sale or transfer of any firearm, the dealer shall mail or deliver
80 the written consent form required by subsection A to the Department of State Police. The State Police shall
81 immediately initiate a search of all available criminal history record information to determine if the purchaser
82 is prohibited from possessing or transporting a firearm under state or federal law. If the search discloses
83 information indicating that the buyer or transferee is so prohibited from possessing or transporting a firearm,
84 the State Police shall inform the chief law-enforcement officer in the jurisdiction where the sale or transfer
85 occurred and the dealer without delay.

86 5. Notwithstanding any other provisions of this section, rifles and shotguns may be purchased by persons
87 who are citizens of the United States or persons lawfully admitted for permanent residence but residents of
88 other states under the terms of subsections A and B upon furnishing the dealer with one photo-identification
89 form issued by a governmental agency of the person's state of residence and one other form of identification
90 determined to be acceptable by the Department of Criminal Justice Services.

91 6. For the purposes of this subsection, the phrase "dealer's fifth business day" does not include December
92 25.

93 C. No dealer shall sell, rent, trade, or transfer from his inventory any firearm, except when the transaction
94 involves a rifle or a shotgun and can be accomplished pursuant to the provisions of subdivision B 5, to any
95 person who is a dual resident of Virginia and another state pursuant to applicable federal law unless he has
96 first obtained from the Department of State Police a report indicating that a search of all available criminal
97 history record information has not disclosed that the person is prohibited from possessing or transporting a
98 firearm under state or federal law.

99 To establish personal identification and dual resident eligibility for purposes of this subsection, a dealer
100 shall require any prospective purchaser to present one photo-identification form issued by a governmental
101 agency of the prospective purchaser's state of legal residence and other documentation of dual residence
102 within the Commonwealth. The other documentation of dual residence in the Commonwealth may include (i)
103 evidence of currently paid personal property tax or real estate tax or a current (a) lease, (b) utility or telephone
104 bill, (c) voter registration card, (d) bank check, (e) passport, (f) automobile registration, or (g) hunting or
105 fishing license; (ii) other current identification allowed as evidence of residency by 27 C.F.R. § 178.124 and
106 ATF Ruling 2001-5; or (iii) other documentation of residence determined to be acceptable by the Department
107 of Criminal Justice Services and that corroborates that the prospective purchaser currently resides in Virginia.

108 D. If any buyer or transferee is denied the right to purchase a firearm under this section, he may exercise
109 his right of access to and review and correction of criminal history record information under § 9.1-132 or
110 institute a civil action as provided in § 9.1-135, provided any such action is initiated within 30 days of such
111 denial.

112 E. Any dealer who willfully and intentionally requests, obtains, or seeks to obtain criminal history record
113 information under false pretenses, or who willfully and intentionally disseminates or seeks to disseminate
114 criminal history record information except as authorized in this section, ~~shall be~~ is guilty of a Class 2
115 misdemeanor.

116 F. For purposes of this section:

117 "Actual buyer" means a person who executes the consent form required in subsection B or C, or other
118 such firearm transaction records as may be required by federal law.

119 "Antique firearm" means:

120 1. Any firearm (including any firearm with a matchlock, flintlock, percussion cap, or similar type of
121 ignition system) manufactured in or before 1898;

122 2. Any replica of any firearm described in subdivision 1 of this definition if such replica (i) is not designed
123 or redesigned for using rimfire or conventional centerfire fixed ammunition or (ii) uses rimfire or
124 conventional centerfire fixed ammunition that is no longer manufactured in the United States and that is not
125 readily available in the ordinary channels of commercial trade;

126 3. Any muzzle-loading rifle, muzzle-loading shotgun, or muzzle-loading pistol that is designed to use
127 black powder, or a black powder substitute, and that cannot use fixed ammunition. For purposes of this
128 subdivision, the term "antique firearm" shall not include any weapon that incorporates a firearm frame or
129 receiver, any firearm that is converted into a muzzle-loading weapon, or any muzzle-loading weapon that can
130 be readily converted to fire fixed ammunition by replacing the barrel, bolt, breech-block, or any combination
131 thereof; or

132 4. Any curio or relic as defined in this subsection.

133 "Assault firearm" means ~~any~~:

134 1. A semi-automatic center-fire rifle or pistol ~~which~~ *that* expels single or multiple projectiles by action of
135 an explosion of a combustible material ~~and is equipped at the time of the offense with a magazine which will~~
136 ~~hold more than 20 rounds of ammunition or designed by the manufacturer to accommodate a silencer or~~
137 ~~equipped with a folding stock with a fixed magazine capacity in excess of 10 rounds;~~

138 2. A semi-automatic center-fire rifle *that expels single or multiple projectiles by action of an explosion of*
139 *a combustible material that has the ability to accept a detachable magazine and has one of the following*
140 *characteristics: (i) a folding, telescoping, or collapsible stock; (ii) a pistol grip that protrudes conspicuously*
141 *beneath the action of the rifle; (iii) a second handgrip or a protruding grip that can be held by the non-*
142 *trigger hand; (iv) a grenade launcher; (v) a flare launcher; (vi) a sound suppressor; (vii) a flash suppressor;*
143 *(viii) a muzzle brake; (ix) a muzzle compensator; (x) a threaded barrel capable of accepting (a) a sound*
144 *suppressor, (b) a flash suppressor, (c) a muzzle brake, or (d) a muzzle compensator; or (xi) any*
145 *characteristic of like kind as enumerated in clauses (i) through (x);*

146 3. A semi-automatic center-fire pistol *that expels single or multiple projectiles by action of an explosion of*
147 *a combustible material that has the ability to accept a detachable magazine and has one of the following*
148 *characteristics: (i) a folding, telescoping, or collapsible stock; (ii) a second handgrip or a protruding grip*
149 *that can be held by the non-trigger hand; (iii) the capacity to accept a magazine that attaches to the pistol*
150 *outside of the pistol grip; (iv) a shroud that is attached to, or partially or completely encircles, the barrel and*
151 *that permits the shooter to hold the pistol with the non-trigger hand without being burned; (v) a threaded*
152 *barrel capable of accepting (a) a sound suppressor, (b) a flash suppressor, (c) a barrel extender, or (d) a*
153 *forward handgrip; or (vi) any characteristic of like kind as enumerated in clauses (i) through (v);*

154 4. A semi-automatic shotgun *that expels single or multiple projectiles by action of an explosion of a*
155 *combustible material that has one of the following characteristics: (i) a folding, telescoping, or collapsible*
156 *stock; (ii) a pistol grip that protrudes conspicuously beneath the action of the shotgun; (iii) the ability to*
157 *accept a detachable magazine; (iv) a fixed magazine capacity in excess of seven rounds; or (v) any*
158 *characteristic of like kind as enumerated in clauses (i) through (iv); or*

159 5. A shotgun with a magazine that will hold more than seven rounds of the shortest ammunition for which
160 it is chambered.

161 An "assault firearm" *does not include any firearm that is an antique firearm, has been rendered*
162 *permanently inoperable, or is manually operated by bolt, pump, lever, or slide action.*

163 "Curios or relics" means firearms that are of special interest to collectors by reason of some quality other
164 than is associated with firearms intended for sporting use or as offensive or defensive weapons. To be
165 recognized as curios or relics, firearms must fall within one of the following categories:

166 1. Firearms that were manufactured at least 50 years prior to the current date, which use rimfire or
167 conventional centerfire fixed ammunition that is no longer manufactured in the United States and that is not
168 readily available in the ordinary channels of commercial trade, but not including replicas thereof;

169 2. Firearms that are certified by the curator of a municipal, state, or federal museum that exhibits firearms
170 to be curios or relics of museum interest; and

171 3. Any other firearms that derive a substantial part of their monetary value from the fact that they are
172 novel, rare, bizarre, or because of their association with some historical figure, period, or event. Proof of
173 qualification of a particular firearm under this category may be established by evidence of present value and
174 evidence that like firearms are not available except as collectors' items, or that the value of like firearms
175 available in ordinary commercial channels is substantially less.

176 "Dealer" means any person licensed as a dealer pursuant to 18 U.S.C. § 921 et seq.

177 "Firearm" means any handgun, shotgun, or rifle that will or is designed to or may readily be converted to
178 expel single or multiple projectiles by action of an explosion of a combustible material.

179 "Handgun" means any pistol or revolver or other firearm originally designed, made and intended to fire
180 single or multiple projectiles by means of an explosion of a combustible material from one or more barrels

181 when held in one hand.

182 "Lawfully admitted for permanent residence" means the status of having been lawfully accorded the
183 privilege of residing permanently in the United States as an immigrant in accordance with the immigration
184 laws, such status not having changed.

185 G. The Department of Criminal Justice Services shall promulgate regulations to ensure the identity,
186 confidentiality, and security of all records and data provided by the Department of State Police pursuant to
187 this section.

188 H. The provisions of this section shall not apply to (i) transactions between persons who are licensed as
189 firearms importers or collectors, manufacturers or dealers pursuant to 18 U.S.C. § 921 et seq.; (ii) purchases
190 by or sales to any law-enforcement officer or agent of the United States, the Commonwealth or any local
191 government, or any campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title
192 23.1; or (iii) antique firearms or curios or relics.

193 I. The provisions of this section shall not apply to restrict purchase, trade, or transfer of firearms by a
194 resident of Virginia when the resident of Virginia makes such purchase, trade, or transfer in another state, in
195 which case the laws and regulations of that state and the United States governing the purchase, trade, or
196 transfer of firearms shall apply. A National Instant Criminal Background Check System (NICS) check shall
197 be performed prior to such purchase, trade, or transfer of firearms.

198 J. All licensed firearms dealers shall collect a fee of \$2 for every transaction for which a criminal history
199 record information check is required pursuant to this section, except that a fee of \$5 shall be collected for
200 every transaction involving an out-of-state resident. Such fee shall be transmitted to the Department of State
201 Police by the last day of the month following the sale for deposit in a special fund for use by the State Police
202 to offset the cost of conducting criminal history record information checks under the provisions of this
203 section.

204 K. Any person willfully and intentionally making a materially false statement on the consent form
205 required in subsection B or C or on such firearm transaction records as may be required by federal law ~~shall~~
206 ~~be is~~ guilty of a Class 5 felony.

207 L. Except as provided in § 18.2-308.2:1, any dealer who willfully and intentionally sells, rents, trades, or
208 transfers a firearm in violation of this section ~~shall be is~~ guilty of a Class 6 felony.

209 L1. Any person who attempts to solicit, persuade, encourage, or entice any dealer to transfer or otherwise
210 convey a firearm other than to the actual buyer, as well as any other person who willfully and intentionally
211 aids or abets such person, ~~shall be is~~ guilty of a Class 6 felony. This subsection shall not apply to a federal
212 law-enforcement officer or a law-enforcement officer as defined in § 9.1-101, in the performance of his
213 official duties, or other person under his direct supervision.

214 M. Any person who purchases a firearm with the intent to (i) resell or otherwise provide such firearm to
215 any person who he knows or has reason to believe is ineligible to purchase or otherwise receive from a dealer
216 a firearm for whatever reason or (ii) transport such firearm out of the Commonwealth to be resold or
217 otherwise provided to another person who the transferor knows is ineligible to purchase or otherwise receive
218 a firearm; ~~shall be is~~ guilty of a Class 4 felony and sentenced to a mandatory minimum term of imprisonment
219 of one year. However, if the violation of this subsection involves such a transfer of more than one firearm, the
220 person shall be sentenced to a mandatory minimum term of imprisonment of five years. The prohibitions of
221 this subsection shall not apply to the purchase of a firearm by a person for the lawful use, possession, or
222 transport thereof, pursuant to § 18.2-308.7, by his child, grandchild, or individual for whom he is the legal
223 guardian if such child, grandchild, or individual is ineligible, solely because of his age, to purchase a firearm.

224 N. Any person who is ineligible to purchase or otherwise receive or possess a firearm in the
225 Commonwealth who solicits, employs, or assists any person in violating subsection M ~~shall be is~~ guilty of a
226 Class 4 felony and shall be sentenced to a mandatory minimum term of imprisonment of five years.

227 O. Any mandatory minimum sentence imposed under this section shall be served consecutively with any
228 other sentence.

229 P. All driver's licenses issued on or after July 1, 1994, shall carry a letter designation indicating whether
230 the driver's license is an original, duplicate, or renewed driver's license.

231 Q. Prior to selling, renting, trading, or transferring any firearm owned by the dealer but not in his
232 inventory to any other person, a dealer may require such other person to consent to have the dealer obtain
233 criminal history record information to determine if such other person is prohibited from possessing or
234 transporting a firearm by state or federal law. The Department of State Police shall establish policies and
235 procedures in accordance with 28 C.F.R. § 25.6 to permit such determinations to be made by the Department
236 of State Police, and the processes established for making such determinations shall conform to the provisions
237 of this section.

238 R. Except as provided in subdivisions 1 and 2, it ~~shall be is~~ unlawful for any person who is not a licensed
239 firearms dealer to purchase more than one handgun within any 30-day period. For the purposes of this
240 subsection, "purchase" does not include the exchange or replacement of a handgun by a seller for a handgun
241 purchased from such seller by the same person seeking the exchange or replacement within the 30-day period
242 immediately preceding the date of exchange or replacement. A violation of this subsection is punishable as a

243 Class 1 misdemeanor.

244 1. Purchases in excess of one handgun within a 30-day period may be made upon completion of an
 245 enhanced background check, as described in this subsection, by special application to the Department of State
 246 Police listing the number and type of handguns to be purchased and transferred for lawful business or
 247 personal use, in a collector series, for collections, as a bulk purchase from estate sales, and for similar
 248 purposes. Such applications shall be signed under oath by the applicant on forms provided by the Department
 249 of State Police, shall state the purpose for the purchase above the limit, and shall require satisfactory proof of
 250 residency and identity. Such application shall be in addition to the firearms sales report required by the
 251 federal Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). The Superintendent of State Police
 252 shall promulgate regulations, pursuant to the Administrative Process Act (§ 2.2-4000 et seq.), for the
 253 implementation of an application process for purchases of handguns above the limit.

254 Upon being satisfied that these requirements have been met, the Department of State Police shall
 255 immediately issue to the applicant a nontransferable certificate, which shall be valid for seven days from the
 256 date of issue. The certificate shall be surrendered to the dealer by the prospective purchaser prior to the
 257 consummation of such sale and shall be kept on file at the dealer's place of business for inspection as
 258 provided in § 54.1-4201 for a period of not less than two years. Upon request of any local law-enforcement
 259 agency, and pursuant to its regulations, the Department of State Police may certify such local
 260 law-enforcement agency to serve as its agent to receive applications and, upon authorization by the
 261 Department of State Police, issue certificates immediately pursuant to this subdivision. Applications and
 262 certificates issued under this subdivision shall be maintained as records as provided in subdivision B 3. The
 263 Department of State Police shall make available to local law-enforcement agencies all records concerning
 264 certificates issued pursuant to this subdivision and all records provided for in subdivision B 3.

265 2. The provisions of this subsection shall not apply to:

266 a. A law-enforcement agency;

267 b. An agency duly authorized to perform law-enforcement duties;

268 c. A state or local correctional facility;

269 d. A private security company licensed to do business within the Commonwealth;

270 e. The purchase of antique firearms;

271 f. A person whose handgun is stolen or irretrievably lost who deems it essential that such handgun be
 272 replaced immediately. Such person may purchase another handgun, even if the person has previously
 273 purchased a handgun within a 30-day period, provided that (i) the person provides the firearms dealer with a
 274 copy of the official police report or a summary thereof, on forms provided by the Department of State Police,
 275 from the law-enforcement agency that took the report of the lost or stolen handgun; (ii) the official police
 276 report or summary thereof contains the name and address of the handgun owner, a description of the
 277 handgun, the location of the loss or theft, the date of the loss or theft, and the date the loss or theft was
 278 reported to the law-enforcement agency; and (iii) the date of the loss or theft as reflected on the official police
 279 report or summary thereof occurred within 30 days of the person's attempt to replace the handgun. The
 280 firearms dealer shall attach a copy of the official police report or summary thereof to the original copy of the
 281 Virginia firearms transaction report completed for the transaction and retain it for the period prescribed by the
 282 Department of State Police;

283 g. A person who trades in a handgun at the same time he makes a handgun purchase and as a part of the
 284 same transaction, provided that no more than one transaction of this nature is completed per day;

285 h. A person who holds a valid Virginia permit to carry a concealed handgun;

286 i. A person who purchases a handgun in a private sale. For purposes of this subdivision, "private sale"
 287 means a purchase from a person who makes occasional sales, exchanges, or purchases of firearms for the
 288 enhancement of a personal collection of curios or relics or who sells all or part of such collection of curios
 289 and relics; or

290 j. A law-enforcement officer. For purposes of this subdivision, "law-enforcement officer" means any
 291 employee of a police department or sheriff's office that is part of or administered by the Commonwealth or
 292 any political subdivision thereof and who is responsible for the prevention and detection of crime and the
 293 enforcement of the penal, traffic, or highway laws of the Commonwealth.

294 *S. No person shall purchase an assault firearm from a dealer unless such person is 21 years of age or
 295 older.*

296 *T. No dealer shall sell, rent, trade, or transfer from his inventory an assault firearm to any person unless
 297 such person is 21 years of age or older.*

298 **2. That the provisions of this act may result in a net increase in periods of imprisonment or**
 299 **commitment. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the necessary**
 300 **appropriation cannot be determined for periods of imprisonment in state adult correctional facilities;**
 301 **therefore, Chapter 2 of the Acts of Assembly of 2024, Special Session I, requires the Virginia Criminal**
 302 **Sentencing Commission to assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4 of the**
 303 **Code of Virginia, the estimated amount of the necessary appropriation cannot be determined for**
 304 **periods of commitment to the custody of the Department of Juvenile Justice.**
