## 1 VIRGINIA ACTS OF ASSEMBLY - CHAPTER 2 An Act to amend and reenact § 3.1, as amended, and §§ 3.2 and 3.3 of Chapter 131 of the Acts of Assembly of 3 1977, which provided a charter for the Town of Brodnax in Brunswick and Mecklenburg Counties, relating to election of mayor; vacancies on town council. 4 5 [H 1669] 6 Approved 7 Be it enacted by the General Assembly of Virginia: 1. That § 3.1, as amended, and §§ 3.2 and 3.3 of Chapter 131 of the Acts of Assembly of 1977 are 8 9 amended and reenacted as follows: § 3.1. Election, qualification and term of office of councilmen and mayor. 10 The town of Brodnax shall be governed by a town council composed of seven councilmen and a mayor, 11 all of whom shall be qualified voters of the town, to be elected from the town at large. Any person qualified 12 to vote in the town shall be eligible for the office of councilman or mayor. The mayor and councilmen in 13 14 office at the time of the passage of this act shall continue in office until the expiration of the terms for which 15 they were elected or until their successors are duly elected and qualified. An election for mayor and 16 councilmen shall be held on the first Tuesday in May, nineteen hundred seventy-eight and on the first Tuesday in May of every second year thereafter and take office on the first day of July succeeding their 17 18 election, provided that the mayor and councilmen elected the first Tuesday in May, nineteen hundred 19 seventy-eight, shall not take office until September one, nineteen hundred seventy-eight, to serve for terms of 20 one year ten months. Thereafter they shall each serve for a term of two years or until their successors have 21 qualified. 22 However, beginning in 2009, the election for mayor and councilmen shall be held at the time of the 23 November general election with elected members to take office on the first day of January succeeding their 24 election. The terms of council members in office at the time of the November 2009 election shall end on 25 January 1, 2010. The mayor and the three members of town council receiving the highest number of votes in 26 the November 2009 election shall serve four-year terms. The other four persons elected to town council in 27 November 2009 shall serve two-year terms. Thereafter, all council members shall be elected for four-year 28 terms. 29 Beginning in 2019, the town shall be governed by a town council composed of five councilmen and a 30 mayor. Three councilmen shall be elected to four-year terms at the November 2019 election, and the mayor 31 and two councilmen shall be elected to four-year terms at the November 2021 election. 32 Notwithstanding any contrary provisions of this section, the mayor elected in November 2025 shall be 33 elected for a term of two years but thereafter shall be elected for a term of four years. 34 § 3.2. Vacancies on council. Vacancies on the council shall be filled for the unexpired portion of the term from among the qualified 35 voters of the town, by a majority vote of the remaining members of the council pursuant to the provisions of 36 37 § 24.2-228 of the Code of Virginia. § 3.3. Vacancy in office of mayor. 38 39 A vacancy in the office of mayor shall be filled for the unexpired portion of the term from among the qualified voters of the town, including the members of the council, by a majority vote of the council pursuant 40 41 to the provisions of § 24.2-228 of the Code of Virginia.
