## 1 VIRGINIA ACTS OF ASSEMBLY - CHAPTER 2 An Act to amend and reenact § 2.2-2497 of the Code of Virginia, relating to Office of New Americans 3 Advisory Board; increase in membership. 4 [H 2779] 5 Approved Be it enacted by the General Assembly of Virginia: 6 1. That § 2.2-2497 of the Code of Virginia is amended and reenacted as follows: 7 8 § 2.2-2497. Membership; terms; compensation and expenses. 9 A. The Board shall consist of 18 21 nonlegislative citizen members appointed by the Governor who represent or have experience with the faith community; local government; the U.S. Citizenship and 10 Immigration Service; law-enforcement agencies; health, mental health, housing, and workforce development 11 organizations; organizations serving youth and the elderly; organizations providing legal services for 12 immigrants; and educational institutions and institutions of higher education. In addition, the Secretaries of 13 14 Commerce and Trade, Education, Health and Human Resources, Labor, Public Safety and Homeland 15 Security, and Transportation, the Director of Diversity, Equity, and Inclusion for the Commonwealth, and the Chairmen of the Virginia-Asian Advisory Board, the Latino Advisory Board, the Virginia African American 16 17 Advisory Board, and the Council on Women, or their designees, shall serve ex officio with nonvoting 18 privileges. Nonlegislative citizen members of the Board shall be residents of the Commonwealth. 19 Ex officio members shall serve terms <del>consistent</del> *coincident* with their terms of office. 20 B. After the initial staggering of terms, nonlegislative citizen members shall be appointed for a term of 21 four years. Appointments to fill vacancies shall be for the unexpired terms. No nonlegislative citizen member shall serve more than two consecutive four-year terms; however, the remainder of any term to which a 22 23 member is appointed to fill a vacancy shall not constitute a term in determining the member's eligibility for 24 reappointment. 25 C. The Board shall elect from its membership a chairman and vice-chairman. A majority of the members 26 of the Board shall constitute a quorum. Meetings of the Board shall be limited to four per year and shall be 27 held upon the call of the chairman or whenever the majority of the members so request. 28 D. Members of the Board shall receive no compensation for their services but shall be reimbursed for all 29 reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 30 2.2-2825. 2. That the initial terms of the three nonlegislative citizen members added to the Office of New 31 Americans Advisory Board pursuant to this act shall be staggered as follows: one member shall be 32 33 appointed for a term of one year; one member shall be appointed for a term of two years; and one

34 member shall be appointed for a term of three years.
