2 An Act to amend the Code of Virginia by adding in Chapter 1 of Title 9.1 an article numbered 17, consisting
 3 of a section numbered 9.1-194, relating to the Virginia Center for Firearm Violence Intervention and
 4 Prevention; creation.

7 **Be it enacted by the General Assembly of Virginia:**

8 **1. That the Code of Virginia is amended by adding in Chapter 1 of Title 9.1 an article numbered 17,**
 9 **consisting of a section numbered 9.1-194, as follows:**

10 *Article 17.*11 *Virginia Center for Firearm Violence Intervention and Prevention.*12 **§ 9.1-194. Virginia Center for Firearm Violence Intervention and Prevention created; duties.**

13 A. From such funds as may be appropriated, the Virginia Center for Firearm Violence Intervention and
 14 Prevention (the Center) is hereby established within the Department. The Center shall:

15 1. Serve as the Commonwealth's primary resource for research, best practices, and strategies for the
 16 implementation of firearm violence intervention, community-based intervention, and group violence
 17 intervention programs designed to reduce violence in communities;

18 2. Operate a statewide firearm violence intervention and prevention research center. The Center shall
 19 serve as the Commonwealth's clearinghouse for data regarding firearm violence and firearm violence
 20 intervention and prevention programs collected by state and local agencies and shall maintain an integrated
 21 information system containing data, research, and statistical information regarding firearm violence in the
 22 Commonwealth;

23 3. Facilitate sharing of data regarding firearm violence and firearm violence intervention and prevention
 24 programs among state and local agencies, including local health departments, institutions of higher
 25 education, research institutions, hospitals and other medical care facilities, community-based organizations,
 26 and law-enforcement agencies;

27 4. In conjunction with the Department of Health, Department of Social Services, Department of
 28 Behavioral Health and Developmental Services, Department of Education, and Department of Veterans
 29 Services, work to enhance programs and strategies designed to address firearm violence, including programs
 30 that focus on the prevention of suicide or domestic violence in the populations served by such departments;

31 5. Facilitate coordination between state agencies, localities, and community-based organizations to
 32 develop comprehensive practices for addressing firearm violence and implementing firearm violence
 33 intervention and prevention programs;

34 6. Develop and publish best practices for establishing firearm violence intervention and prevention
 35 programs, including street outreach, hospital-based violence intervention, community-based violence
 36 intervention, and group violence intervention programs;

37 7. Provide technical assistance to localities and community-based organizations to support the
 38 establishment of firearm violence intervention and prevention programs, including technical assistance on
 39 capacity building, obtaining grant funding, and collecting data;

40 8. From such funds as may be appropriated, provide grants to agencies of local government, community-
 41 based organizations, and hospitals for the purpose of supporting implementation of evidence-informed
 42 firearm violence intervention and prevention efforts, including street outreach, hospital-based violence
 43 intervention, community-based violence intervention, and group violence intervention programs;

44 9. Evaluate state and community-based violence intervention programs and policies that receive funding
 45 through the Center;

46 10. Produce reports and provide analysis and interpretation of statistical information regarding firearm
 47 violence, including information on firearm trafficking, crimes involving firearms, mass shootings, suicides,
 48 and fatal and nonfatal firearm injuries;

49 11. Establish training standards and publish and periodically update model policies for law-enforcement
 50 personnel containing best practices for (i) the service and execution of substantial risk orders and protective
 51 orders, (ii) the processes for obtaining a firearm from an individual prohibited from possessing a firearm,
 52 and (iii) addressing the different types of firearm violence, including unintentional injuries, mass shootings,
 53 domestic violence, suicides, homicides, and community violence; and

54 12. Apply for and accept grants from the United States government or any other source in carrying out
 55 the purposes of this article and accept any and all donations, both real and personal, and grants of money
 56 from any governmental unit or public agency, or from any institution, person, firm, or corporation, and may

57 *receive, utilize, and dispose of the same. Any moneys received pursuant to this section shall be deposited in*
58 *the state treasury to the account of the Department.*

59 *B. The Center may require and shall receive from every department, division, board, bureau, commission,*
60 *authority, or other agency created by the Commonwealth, or to which the Commonwealth is a party, or any*
61 *political subdivision thereof, cooperation and assistance in the performance of its duties. The Center may*
62 *also consult and exchange information with local government agencies and interested stakeholders,*
63 *institutions of higher education, research institutions, hospitals and other medical care facilities, and*
64 *community-based organizations.*

65 *C. The Center shall report annually on or before October 1 to the Governor and the General Assembly.*
66 *The report shall include a summary of activities for the year and any recommendations to address firearm*
67 *violence within the Commonwealth. The Department shall ensure that such report is available to the public.*

68 **2. That the provisions of this act shall become effective on July 1, 2026.**
