WHEREAS, each Taco Bamba Taqueria is known for featuring unique menu items that reflect the local community where the restaurant is located, and the Taco Bamba Taqueria in Sterling will celebrate the rich tapestry of cultures in Eastern Loudoun County with offerings such as the Habibi G with brisket shawarma, the Pork Pingao taco, and the Doña Rosi, a tribute to Victor Albisu's mother and their Peruvian heritage; and

WHEREAS, by consistently pushing the boundaries on what may be considered tacos and Mexican street food, Taco Bamba Taqueria cultivates an exciting and dynamic dining experience that keeps customers coming back for more; and

WHEREAS, every year, each Taco Bamba Taqueria location competes in the Bambathon, when a dollar from each taco sold goes to Smile on the World, a nonprofit organization founded by Victor Albisu to promote food safety and improve dental care in impoverished areas of Latin America; and

WHEREAS, with an uncompromising commitment to quality food and service, Taco Bamba Taqueria has brightened countless lives in Northern Virginia and beyond; now, therefore, be it
