Every time it rains, oil, dirt, and other pollutants are carried from rooftops and roads to local waterways. While stormwater is regulated under the federal Clean Water Act, it remains the fastest growing source of polluted runoff to the Chesapeake Bay and its tributaries, hampering our ability to meet our load reductions and restore our impaired waterways. What programs do our states have in place to control runoff from impervious surfaces? What can we learn from our neighbors?
