# VIRGINIA ACTS OF ASSEMBLY - 2025 RECONVENED SESSION

#### **CHAPTER 700**

An Act to amend the Code of Virginia by adding in Chapter 2 of Title 32.1 an article numbered 23, consisting of sections numbered 32.1-73.28 through 32.1-73.31, relating to Postpartum Depression Education Act; report.

### Approved May 2, 2025

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding in Chapter 2 of Title 32.1 an article numbered 23, consisting of sections numbered 32.1-73.28 through 32.1-73.31, as follows:

Article 23.

Postpartum Depression Education Act.

## § 32.1-73.28. Public awareness campaign; Department authorized to seek funding.

- A. The Department, in collaboration with the Department of Behavioral Health and Developmental Services, shall develop and implement a statewide public awareness campaign on perinatal and postpartum depression. Such campaign shall:
- 1. Increase awareness about the symptoms, risk factors, and treatment options for perinatal and postpartum depression;
  - 2. Provide culturally appropriate and accessible materials for diverse populations;
- 3. Provide information to health care providers, birthing individuals, families, and community organizations;
- 4. Utilize multiple platforms, including digital media, print materials, and community outreach programs, to maximize public engagement; and
- 5. Highlight the importance of seeking early treatment for and reducing the stigma associated with perinatal and postpartum depression.
- B. The Department may seek and accept funding from any public or private entities to implement the provisions of this article.

#### § 32.1-73.29. Development of educational materials and resources.

- A. The Department shall create and distribute educational materials on perinatal and postpartum depression. Such materials shall include:
  - 1. Fact sheets on symptoms, causes, and available treatment options;
- 2. Contact information for local, state, and national resources, including crisis hotlines, counseling services, and support groups;
- 3. Guidance for health care providers on screening, diagnosing, and managing perinatal and postpartum depression; and
- 4. Information on the impact of untreated perinatal and postpartum depression on maternal and infant health outcomes.
  - B. The Department shall distribute materials prepared pursuant to subsection A to:
  - 1. Health care providers, including obstetricians, midwives, pediatricians, and primary care physicians;
  - 2. Hospitals, birthing centers, and clinics;
  - 3. Community organizations, including faith-based groups and nonprofit organizations; and
  - 4. Public health offices and other relevant government agencies.

## § 32.1-73.30. Online resource hub.

The Department shall develop and maintain an online resource hub that provides:

- 1. Up-to-date information on perinatal and postpartum depression;
- 2. A directory of mental health providers specializing in perinatal and postpartum care;
- 3. Information on available support groups, counseling services, and treatment options; and
- 4. A platform for individuals and families to share experiences and connect with community resources.

# § 32.1-73.31. Annual report.

- A. The Department shall submit an annual report to the Governor and the General Assembly that includes:
  - 1. Metrics on public engagement with the programs implemented pursuant to this article;
- 2. Feedback from health care providers, community organizations, and individuals served by programs implemented pursuant to this article;
- 3. Progress in reducing stigma and increasing early detection and treatment of perinatal and postpartum depression; and
  - 4. Recommendations for improving or expanding programs implemented pursuant to this article.
  - B. The Department shall publish the annual report prepared pursuant to subsection A on its website.

2. That the Department of Health shall submit the first report prepared pursuant to  $\S$  32.1-73.31 of the Code of Virginia, as created by this act, by November 1, 2026.
