A BILL to amend and reenact §§ 55.1-1300 and 55.1-1308 of the Code of Virginia; to amend the Code of Virginia by adding sections numbered 55.1-1308.3, 55.1-1308.4, and 55.1-1308.5; and to repeal § 55.1-1308.2 of the Code of Virginia, relating to Manufactured Home Lot Rental Act; right of first refusal; resident entities and localities.

Be it enacted by the General Assembly of Virginia:

1. That §§ 55.1-1300 and 55.1-1308 of the Code of Virginia are amended and reenacted and that the Code of Virginia is amended by adding sections numbered 55.1-1308.3, 55.1-1308.4, and 55.1-1308.5 as follows:

§ 55.1-1300. Definitions.

As used in this chapter, unless the context requires a different meaning:

"Abandoned manufactured home" means a manufactured home occupying a manufactured home lot pursuant to a written agreement under which (i) the tenant has defaulted in rent or (ii) the landlord has the right to terminate the written rental agreement pursuant to § 55.1-1249.

"Guest or invitee" means a person, other than the tenant, who has the permission of the tenant to visit but not to occupy the premises.

"Landlord" means the manufactured home park owner or the lessor or sublessor of a manufactured home park. "Landlord" also means a manufactured home park operator who fails to disclose the name of such owner, lessor, or sublessor as provided in § 55.1-1216.

"Locality" means the same as that term is defined in § 15.2-102.

"Manufactured home" means a structure, transportable in one or more sections, that in the traveling mode is eight body feet or more in width or 40 body feet or more in length, or, when erected on site, is 320 or more square feet, and that is built on a permanent chassis and designed to be used as a dwelling with or without a permanent foundation when connected to the required utilities, and includes the plumbing, heating, air-conditioning, and electrical systems contained in the structure.

"Manufactured home lot" means a parcel of land within the boundaries of a manufactured home park provided for the placement of a single manufactured home and the exclusive use of its occupants.

"Manufactured home owner" means the owner of a manufactured home.

"Manufactured home park" means a parcel of land under single or common ownership upon which five or more manufactured homes are located on a continual, nonrecreational basis together with any structure, equipment, road, or facility intended for use incidental to the occupancy of the manufactured homes. "Manufactured home park" does not include a premises used solely for storage or display of uninhabited manufactured homes or a premises occupied solely by a landowner and members of his family.

"Manufactured home park operator" means a person employed or contracted by a manufactured home park owner or landlord to manage a manufactured home park.

"Manufactured home park owner" means a person who owns land that accommodates a manufactured home park.

"Owner" means one or more persons, jointly or severally, in whom is vested (i) all or part of the legal title to the property or (ii) all or part of the beneficial ownership and right to present use and enjoyment of the premises. "Owner" includes a mortgagee in possession.

"Reasonable charges in addition to rent" means any routine maintenance and utility charges for which the tenant is liable under the rental agreement.

"Rent" means payments made by the tenant to the landlord for use of a manufactured home lot and other facilities or services provided by the landlord.

"Rental agreement" means any agreement, written or oral, and valid rules and regulations adopted in conformance with § 55.1-1228 embodying the terms and conditions concerning the use and occupancy of a manufactured home lot and premises and other facilities or services provided by the landlord.

"Resident entity" means a formal or informal entity that provides documentation that it represents at least 25 percent of the tenants with a valid rental agreement in the manufactured home park at the time an offer to purchase the manufactured home park is made.

"Secured party" means the same as that term is defined in § 8.9A-102.

"Security interest" means the same as that term is defined in § 8.1A-201.

59 "Tenant" means a person entitled as under a rental agreement to occupy a manufactured home lot to the
60 exclusion of others.

61 **§ 55.1-1308. Termination of tenancy.**

62 A. Notwithstanding the provisions of this section, where a landlord and seller of a manufactured home
63 have in common (i) one or more owners, (ii) immediate family members, or (iii) officers or directors, the
64 rental agreement shall be renewed except for reasons that would justify a termination of the rental agreement
65 or eviction by the landlord as authorized by this chapter.

66 B. A landlord may terminate a rental agreement of any length due to a change in the use of all or any part
67 of a manufactured home park, including conversion to hotel, motel, or other commercial use, planned unit
68 development, rehabilitation, or demolition, by delivering to each tenant, by certified mail, a 180-day written
69 notice stating the date upon which the rental agreement will terminate and the reason for the termination.
70 Such termination notice requirement shall not be waived; however, at the request of the tenant, a period of
71 less than 180 days may be agreed upon by both the landlord and tenant in a written agreement separate from
72 the rental agreement executed after such notice is given. The notice required by this section may be sent
73 concurrently with the notice of intent to sell required by § 55.1-1308.2 55.1-1308.3.

74 **§ 55.1-1308.3. Right of first refusal for resident entities and localities.**

75 A. A manufactured home park owner who accepts a written offer to purchase a manufactured home park
76 from a third party other than a resident entity shall accept such offer contingent upon providing the notice
77 and opportunity to purchase required by this section. Within five business days of entering into a sales
78 contract to sell a manufactured home park, the manufactured home park owner shall provide to each
79 manufactured home park tenant and to the locality in which the manufactured home park is located (i) notice
80 of such sales contract and (ii) information regarding the resident entity's and locality's right to purchase the
81 manufactured home park. Such notice shall describe the terms of the sales contract, including the price and
82 material terms and conditions of the contract, and state that the resident entity and the locality have a right
83 of first refusal. Such notice shall be delivered to (a) the locality's attorney, the presiding officer of the
84 governing body of the locality, or the locality's attorney for the Commonwealth; (b) each manufactured home
85 park owner by certified mail; and (c) each manufactured home in the manufactured home park by personal
86 delivery. The manufactured home park owner shall also deliver the notice required by this section to the
87 Department of Housing and Community Development, which shall post the information on its website within
88 three business days of receipt.

89 B. If, no later than 180 days following receipt of the notice required by this section, the resident entity or
90 the locality in which the manufactured home park is located delivers to the manufactured home park owner a
91 proposed purchase agreement containing the same price and substantially similar terms and conditions as
92 the purchase agreement of which the manufactured home park owner provided notice pursuant to subsection
93 A, the resident entity or the locality shall have the right to purchase the manufactured home park at the price,
94 terms, and conditions stated in its proposed purchase agreement, provided that the purchase agreement
95 contains a commitment from the resident entity or the locality to preserve the property as a manufactured
96 home park for at least 15 years following the sale unless a majority of the tenants with a valid rental
97 agreement in the manufactured home park assert in writing that they consent to the conversion of the
98 manufactured home park to an alternative form of affordable housing. Such commitment shall also be
99 required of any assignee to which a resident entity or locality assigns its rights under subsection I.

100 C. If the sales contract contains any provision penalizing the manufactured home park owner for
101 accepting an alternative offer from the resident entity or locality, such penalty provision shall be void and
102 unenforceable.

103 D. The right of first refusal created pursuant to this section shall be created and conferred with the
104 resident entity having first priority and the locality having second priority.

105 E. The provisions of this section are secondary to the terms of the right of first refusal established by a
106 locality through the contribution of local funds to the acquisition, development, or revitalization of a
107 manufactured home park or within the agreements for assistance from locally managed funds or programs,
108 provided that such terms contain a commitment to preserve the property as a manufactured home park for at
109 least 15 years following the sale unless a majority of the tenants with a valid rental agreement in the
110 manufactured home park assert in writing that they consent to the conversion of the park to an alternative
111 form of affordable housing.

112 F. If a manufactured home park owner fails to comply with any requirement set forth in this section, a
113 locality may bring an action in the circuit court for the locality in which the manufactured home park is
114 located to enforce the manufactured home park owner's obligations under this section, provided that the
115 manufactured home park is located within the jurisdictional boundaries of the locality and the locality has
116 notified the manufactured home park owner of its intent to enforce the manufactured home park owner's
117 obligations under this section. Such enforcement action may include seeking an injunction, damages, or both.

118 G. If a resident entity or locality that purchased a manufactured home park pursuant to subsection B gives
119 notice of its intent to change the use of all or any part of the manufactured home park in violation of the
120 commitment made in the purchase agreement provided to the seller, any person with a valid rental agreement

121 for a lot in the manufactured home park may file an action in the circuit court for the locality in which the
 122 manufactured home park is located seeking injunctive relief, damages, or both. The prevailing party shall
 123 also be entitled to an award of attorney fees.

124 H. If a manufactured home park owner fails to comply with the provisions of this section, any person with
 125 a valid rental agreement for a lot in the manufactured home park may file an action in the circuit court for
 126 the locality in which the manufactured home park is located seeking injunctive relief, damages, or both. Such
 127 damages shall include actual damages and statutory damages equal to 12 times the amount of the monthly lot
 128 rent paid by the tenant or a reasonable amount as determined by the court. The prevailing party shall also be
 129 entitled to an award of attorney fees.

130 I. A locality may assign its rights and responsibilities under this section to an organization exempt from
 131 taxation under § 501(c)(3) of the Internal Revenue Code that provides housing or related services to low-
 132 income residents of the Commonwealth. A resident entity may assign its rights and responsibilities under this
 133 section to a locality or to an organization exempt from taxation under § 501(c)(3) of the Internal Revenue
 134 Code that provides housing or related services to low-income residents of the Commonwealth.

135 J. If a locality does not exercise or assign the rights provided to it through this section, the locality shall
 136 record with the circuit court of the locality in which the manufactured home park is located an affidavit
 137 submitted to the locality by the seller in which the seller has certified that he has complied with the
 138 requirements of this section. The recordation of such affidavit shall be presumptive evidence of compliance
 139 for purposes of good title in the hands of a bona fide purchaser, and failure to record such affidavit shall be
 140 presumptive evidence of noncompliance with this section. If no resident entity makes an offer during the 180-
 141 day period described in subsection B, it shall be presumptive evidence of compliance for purposes of good
 142 title in the hands of a bona fide purchaser.

143 K. The provisions of this section shall not apply to the sale of a manufactured home park to the
 144 manufactured home park owner's family by blood or marriage or to a person or entity that owns a portion of
 145 the manufactured home park at the time of the offer or listing of such manufactured home park for sale.

146 **§ 55.1-1308.4. Opportunity to purchase for resident entities.**

147 A. Notwithstanding any other provision of law, if at any time a resident entity makes an offer to purchase
 148 a manufactured home park, the manufactured home park owner shall consider such offer and negotiate with
 149 such resident entity in good faith. If the manufactured home park owner declines to accept such offer, the
 150 manufactured home park owner shall do so in writing and shall state the good faith reasons for such
 151 rejection. The written denial shall be provided to one or more officers of the resident entity.

152 B. If a manufactured home park owner fails to comply with the provisions of this section, any person with
 153 a valid rental agreement for a lot in the manufactured home park may file an action in the circuit court for
 154 the locality in which the manufactured home park is located seeking injunctive relief, damages, or both. Such
 155 damages shall include actual damages and statutory damages equal to 12 times the amount of the monthly lot
 156 rent paid by the tenant or a reasonable amount as determined by the court. The prevailing party shall also be
 157 entitled to an award of attorney fees.

158 C. All manufactured home park owners shall provide written notice of the rights provided by this section
 159 by mail to each manufactured home park tenant and by personal delivery to each manufactured home in the
 160 manufactured home park at least once annually and shall post written notice of the rights provided by this
 161 section in prominent places throughout the manufactured home park.

162 **§ 55.1-1308.5. Affidavit of compliance with notice requirements.**

163 A seller of a manufactured home park shall record with the circuit court of the locality in which the
 164 manufactured home park is located an affidavit submitted by the seller in which the seller has certified that
 165 he has complied with the requirements of §§ 55.1-1308.3 and 55.1-1308.4. Such affidavit shall include a copy
 166 of the notices sent pursuant to §§ 55.1-1308.3 and 55.1-1308.4.

167 **2. That § 55.1-1308.2 of the Code of Virginia is repealed.**
