4 *A BILL to amend and reenact § 46.2-1550 of the Code of Virginia, relating to dealer's license plates;*

8 **Be it enacted by the General Assembly of Virginia:**9 **1. That § 46.2-1550 of the Code of Virginia is amended and reenacted as follows:**10 **§ 46.2-1550. Use of dealer's and manufacturer's license plates, generally.**11 A. Dealer's license plates may be used on vehicles in the inventory of licensed motor vehicle  
12 manufacturers, distributors, and dealers in the Commonwealth when operated on the highways of Virginia by  
13 dealers or dealer-operators, their spouses, or employees of manufacturers, distributors, and dealers as  
14 permitted in this article, which shall include business, personal, and family purposes. Except as otherwise  
15 explicitly permitted in this article, it shall be unlawful for any dealer to cause or permit: (i) use of dealer's  
16 license plates on vehicles other than those held in inventory for sale or resale; (ii) dealer's license plates to be  
17 lent, leased, rented, or placed at the disposal of any persons other than those permitted by this article to use  
18 dealer's license plates; and (iii) use of dealer's license plates on any vehicle of a type for which their use is not  
19 authorized by this article. Manufacturer's license plates may be used on company vehicles as defined in  
20 § 46.2-602.2 operated on the highways of Virginia as provided in § 46.2-602.2 and as permitted by this  
21 article. It shall be unlawful for any dealer to cause or permit dealer's license plates to be used on:

22 1. Motor vehicles such as tow trucks, wrecking cranes, or other service motor vehicles;

23 2. Vehicles used to deliver or transport (i) other vehicles; (ii) portions of vehicles; (iii) vehicle  
24 components; parts; or accessories; or (iv) fuel, *except when such delivery or transport consists of five gallons*  
25 *or less in a container of a type approved by the Commissioner;*

26 3. Courtesy vehicles; or

27 4. Vehicles used in conjunction with any other business.

28 B. A dealer may permit his license plates to be used in the operation of a motor vehicle:

29 1. By any person whom the dealer reasonably believes to be a bona fide prospective purchaser who is  
30 either accompanied by a licensed salesperson or has the written permission of the dealer;31 2. When the plates are being used by a customer on a vehicle owned by the dealer in whose repair shop  
32 the customer's vehicle is being repaired; or33 3. By a person authorized by the dealer on a vehicle that is being driven to or from (i) a point of sale, (ii)  
34 an auction, (iii) a repair facility for the purpose of mechanical repairs, painting, or installation of parts or  
35 accessories, or (iv) a dealer exchange, or (v) an automotive retail or supply store or retail facility selling  
36 automotive supplies or parts.37 The dealer shall issue to the prospective purchaser, customer whose vehicle is being repaired, or other  
38 person authorized under subdivision 3 of this subsection, a certificate on forms provided by the Department, a  
39 copy of which shall be retained by the dealer and open at all times to the inspection of the Commissioner or  
40 any of the officers or agents of the Department. The certificate shall be in the immediate possession of the  
41 person operating or authorized to operate the vehicle. The certificate shall entitle a person to operate with  
42 dealer's license plates under (i) subdivision 1 or 2 of this subsection for a specific period of no more than five  
43 days or (ii) subdivision 3 of this subsection for no more than twenty-four hours. No more than two certificates  
44 may be issued by a dealer to the same person under subdivision 1 or 2 of this subsection for successive  
45 periods.
