5 artificial intelligence system by mental health service providers; civil penalty.

8 **Be it enacted by the General Assembly of Virginia:**9 **1. That the Code of Virginia is amended by adding a section numbered 54.1-2400.1:1 as follows:**10 **§ 54.1-2400.1:1. Use of artificial intelligence by mental health service providers; civil penalty.**11 **A. As used in this section:**12 "Administrative support" means tasks performed to assist a mental health service provider in the delivery
13 of mental health services that do not involve communication. "Administrative support" includes (i) managing
14 appointment scheduling and reminders, (ii) processing billing and insurance claims, and (iii) drafting
15 general communications related to mental health services logistics that do not include therapy or counseling.16 "Artificial intelligence system" means any machine learning-based system that, for any explicit or implicit
17 objective, infers from the inputs such system receives how to generate outputs, including content, decisions,
18 predictions, and recommendations, that can influence physical or virtual environments. "Artificial
19 intelligence system" does not include any artificial intelligence system or general purpose artificial
20 intelligence model that is used for development, prototyping, and research activities before such artificial
21 intelligence system or general purpose artificial intelligence model is made available to deployers or
22 consumers.

23 "Mental health service provider" has the same meaning as provided in § 54.1-2400.1.

24 "Peer support" means services provided by individuals with lived experience of mental health conditions
25 or recovery from substance use that are intended to offer encouragement, understanding, and guidance
26 without clinical intervention.27 "Religious counseling" means counseling provided by clergy members, pastoral counselors, or other
28 religious leaders acting within the scope of their religious duties if the services are explicitly faith-based and
29 are not represented as clinical mental health services or therapy services.30 "Supplementary support" means tasks performed to assist a mental health service provider in the delivery
31 of therapy or counseling that do not involve therapeutic communication and that are not administrative
32 support. "Supplementary support" includes (i) preparing and maintaining client records, including therapy
33 notes; (ii) analyzing anonymized data to track client progress or identify trends, subject to review by a mental
34 health service provider; and (iii) identifying and organizing external resources or referrals for client use.35 "Therapeutic communication" means any verbal, nonverbal, or written interaction conducted in a clinical
36 or professional setting that is intended to diagnose, treat, or address an individual's mental, emotional, or
37 behavioral health concerns. "Therapeutic communication" includes (i) direct interactions with clients for the
38 purpose of understanding or reflecting on their thoughts, emotions, or experiences; (ii) providing guidance,
39 strategies, or interventions designed to achieve mental health outcomes; (iii) offering emotional support,
40 reassurance, or empathy in response to psychological or emotional distress; (iv) collaborating with clients to
41 develop or modify therapeutic goals or treatment plans; and (v) offering behavioral feedback intended to
42 promote psychological growth or address mental health conditions.43 **B. A mental health service provider may use an artificial intelligence system to assist in providing
44 administrative support or supplementary support in therapy or counseling services if such mental health
45 service provider maintains full responsibility for all interactions, outputs, and data use associated with the
46 system.**47 **No licensed professional shall be permitted to use an artificial intelligence system in providing
48 administrative support or supplemental support in therapy or counseling services pursuant to this subsection
49 when the session is recorded or transcribed unless:**50 **1. The mental health service provider discloses to the patient or the patient's legally authorized
51 representative (i) that an artificial intelligence system will be used and (ii) the specific purpose of the
52 artificial intelligence system that will be used; and**53 **2. At the initial appointment, the mental health service provider discloses its artificial intelligence system
54 use and policies related to such use and the patient or the patient's legally authorized representative provides
55 written consent to the use of an artificial intelligence system as permitted by this section. The mental health
56 service provider shall give notice of any change in its policies related to the use of an artificial intelligence**

59 system to any patient or such patient's legally authorized representative who has consented to the use of an
60 artificial intelligence system pursuant to this subdivision.

61 C. A person may not provide, advertise, or otherwise offer therapy or counseling services, including
62 through the use of an artificial intelligence system, to the public in the Commonwealth unless the therapy or
63 counseling services are conducted by a mental health service provider.

64 D. A mental health service provider may use an artificial intelligence system only to the extent that such
65 use meets the requirements of subsection B. No mental health service provider shall allow an artificial
66 intelligence system to:

67 1. Make independent therapeutic decisions;

68 2. Directly interact with clients in any form of therapeutic communication;

69 3. Generate therapeutic recommendations or treatment plans without review and approval by the licensed
70 professional; or

71 4. Detect emotions or mental states.

72 E. All records kept by a mental health service provider and all communications between an individual
73 seeking therapy or counseling services and a mental health service provider shall be confidential pursuant to
74 the requirements of § 32.1-127.1:03 and shall not be disclosed unless such disclosure complies with the
75 requirements of § 32.1-127.1:03.

76 F. This section does not apply to religious counseling, peer support, or self-help materials and
77 educational resources that are available to the public and do not purport to offer therapy or counseling
78 services.

79 G. Any person who violates the provisions of this section shall be subject to a civil penalty not to exceed
80 \$10,000. Such penalty shall be collected by the Department of Health Professions and shall be deposited into
81 the general fund.
