8 **Be it enacted by the General Assembly of Virginia:**9 **1. That § 51.1-212 of the Code of Virginia is amended and reenacted as follows:**10 **§ 51.1-212. Definitions.**

11 As used in this chapter, unless the context requires a different meaning:

12 "Employee" means any (i) member of the Capitol Police Force as described in § 30-34.2:1, (ii) campus  
13 police officer appointed under the provisions of Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1, (iii)  
14 conservation police officer in the Department of Wildlife Resources appointed under the provisions of  
15 Chapter 2 (§ 29.1-200 et seq.) of Title 29.1, (iv) special agent of the Virginia Alcoholic Beverage Control  
16 Authority appointed under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1, (v) law-enforcement  
17 officer employed by the Virginia Marine Resources Commission as described in § 9.1-101, (vi) correctional  
18 officer as the term is defined in § 53.1-1, and including correctional officers employed at a juvenile correction  
19 facility as the term is defined in § 66-25.3, (vii) parole officer appointed pursuant to § 53.1-143, (viii)  
20 commercial vehicle enforcement officer employed by the Department of State Police, (ix) full-time firefighter  
21 employed by the Department of Military Affairs, ~~and~~ (x) conservation officer of the Department of  
22 Conservation and Recreation appointed under the provisions of Article 4 (§ 10.1-115 et seq.) of Chapter 1 of  
23 Title 10.1, *and* (xi) sworn unit investigator appointed by the Attorney General pursuant to § 32.1-320.1.24 "Member" means any person included in the membership of the Retirement System as provided in this  
25 chapter.

26 "Normal retirement date" means a member's sixtieth birthday.

27 "Retirement System" means the Virginia Law Officers' Retirement System.

28 **2. That the provisions of this act shall become effective on July 1, 2027.**29 **3. That the provisions of this act providing enhanced retirement benefits to positions as a full-time  
30 sworn unit investigator appointed by the Attorney General pursuant to § 32.1-320.1 of the Code of  
31 Virginia shall apply only to service earned as a full-time sworn unit investigator appointed by the  
32 Attorney General pursuant to § 32.1-320.1 of the Code of Virginia on or after July 1, 2027.**
