9 **Be it enacted by the General Assembly of Virginia:**10 **1. That §§ 54.1-403, as it shall become effective, and 54.1-2200.2 of the Code of Virginia are amended**
11 **and reenacted as follows:**12 **§ 54.1-403. (Effective July 1, 2026) Board members and officers; quorum.**13 The Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and
14 Landscape Architects shall be composed of 15 members as follows: three architects, three professional
15 engineers, three land surveyors, two landscape architects, two certified interior designers, and two
16 nonlegislative citizen members.17 Except for the nonlegislative citizen members appointed in accordance with § 54.1-107, Board members
18 shall have actively practiced or taught their professions for at least 10 years prior to their appointments. The
19 terms of Board members shall be four years.

20 The Board shall elect a president and vice-president from its membership.

21 Nine Board members, consisting of ~~two engineers at least one engineer, two architects one architect, two~~
22 ~~one land surveyors surveyor, one landscape architect, one interior designer, and one nonlegislative citizen~~
23 member, shall constitute a quorum.24 **§ 54.1-2200.2. Board for Professional Soil Scientists, Wetland Professionals, and Geologists;**
25 **membership; quorum.**26 A. Notwithstanding the provisions of § 54.1-200, the Board for Professional Soil Scientists, Wetland
27 Professionals, and Geologists shall be composed of 13 members as follows: three licensed professional soil
28 scientists, three certified professional wetland delineators, three licensed professional geologists, and three
29 citizen members. The State Geologist shall serve as an ex officio member of the Board. The professional
30 geologist members shall be of varied backgrounds. The professional soil scientist members shall have
31 experience in at least one of the following areas: (i) soil mapping and classification, (ii) soil suitability and
32 land use, (iii) teaching and research in soil science, and (iv) environmental protection regulations. Of the
33 wetland professional members, one shall have experience in wetland delineation and description, one shall
34 have experience in teaching and research in wetland science, and one shall have experience with natural
35 resource regulations. Terms of the members shall be for four years.36 B. The Board shall annually elect a chairman from its membership. Seven board members, consisting of at
37 least ~~two one professional soil scientists scientist, two one professional wetland delineators delineator, two~~
38 ~~one professional geologists geologist, and one citizen, shall constitute a quorum.~~39 C. The Governor may select the professional soil scientist members from a list of at least three names for
40 each vacancy submitted by the Virginia Association of Professional Soil Scientists. The Governor may notify
41 the Virginia Association of Professional Soil Scientists of any professional vacancy other than by expiration
42 among the professional soil scientist members of the Board and nominations may be made for the filling of
43 the vacancy.44 D. The Governor may select the wetland professionals from a list of at least three names for each vacancy
45 submitted by the Virginia Association of Wetland Professionals. The Governor may notify and request
46 nominations from the Virginia Association of Wetland Professionals of any professional vacancy other than
47 by expiration among the wetland professional members.
