5 *431 of the Acts of Assembly of 1950, which provided a charter for the City of Hopewell, relating to the*  
6 *Hopewell Water Renewal Commission.*

9 **Be it enacted by the General Assembly of Virginia:**

10 **1. That § 1, as amended, § 2, and § 3, as amended, of Chapter XXV (A.1) of Chapter 431 of the Acts of**  
11 **Assembly of 1950 are amended and reenacted as follows:**

12 § 1. Created; general function; composition; appointment and terms of members.

13 There shall be a regional wastewater treatment facility commission which shall be known as the Hopewell  
14 Water Renewal Commission (hereinafter in this chapter referred to as the "Commission"), which shall act on  
15 behalf of the City of Hopewell as hereinafter provided, with respect to a regional wastewater treatment  
16 facility owned by the City of Hopewell to provide treatment for disposal of sanitary and industrial waste from  
17 the City of Hopewell and vicinity. The Commission shall consist of up to ~~nine~~ 10 members, who need not be  
18 residents of the city, and who shall be appointed by a majority of city council. Up to six members shall be  
19 from nominees submitted by manufacturers (each nominating with respect to one membership) which provide  
20 assistance in the planning and financing for the regional wastewater treatment facility or which are or will be  
21 users of said facility. Each new nominating manufacturer, meaning manufacturers or their predecessors  
22 having not previously submitted nominations to the Commission, shall provide a capital contribution in an  
23 amount determined by the city council upon recommendation by the Commission. ~~Three~~ Two additional  
24 members shall be ~~a city councilor~~, the city manager, and ~~the city attorney~~ one member of city council. Upon  
25 becoming users of the facility as contemplated by the relevant facility agreement, the commanding officer of  
26 Fort Lee and the county administrator of Prince George County shall become members of the Commission.  
27 Any vacancy in the appointive membership of the Commission, however occurring, shall be promptly filled  
28 by the city council for the unexpired term in the same manner and from the same source as the original  
29 appointment to the vacated position. *The city manager shall serve as the chairperson of the Commission.*

30 § 2. The City of Hopewell may contract with manufacturers as provided in § 1 above for appointment of  
31 members of the Commission from the nominees of such manufacturers and for maintenance of their majority  
32 representation. Any such contract within the scope of this chapter shall be valid and enforceable. Governance.

33 Every action taken or decision made by the Commission, in addition to requiring agreement by a majority  
34 of its members, shall require agreement by either the city manager or the member of city council to be  
35 effective.

36 § 3. Powers and duties.

37 The Commission shall help and assist in the maintenance and expansion of the facility. The Commission  
38 shall exercise full authority and responsibility in the operation, maintenance, improvement, and repair of the  
39 facility, ~~subject, however, to overrule of any of its actions by the city council.~~ The Commission shall have  
40 such further duties as the city council may from time to time direct.
