5 *numbered 46.2-1419 through 46.2-1427, relating to automated driving systems.*

8 **Be it enacted by the General Assembly of Virginia:**9 **1. That the Code of Virginia is amended by adding in Title 46.2 a chapter numbered 14.2, consisting of**
10 **sections numbered 46.2-1419 through 46.2-1427, as follows:**11 **CHAPTER 14.2.**12 **AUTOMATED DRIVING SYSTEMS.**13 **§ 46.2-1419. Definitions.**14 *As used in this chapter, unless the context requires a different meaning:*15 *"Automated driving system" means hardware and software that are collectively capable of performing the*
16 *entire dynamic driving task on a sustained basis, regardless of whether it is limited to a specific operational*
17 *design domain.*18 *"DDT fallback" means the response by:*19 *1. The person or human driver to either perform the DDT or achieve a minimal risk condition after the*
20 *occurrence of a DDT performance relevant system failure, or upon operational design domain exit; or*21 *2. An automated driving system to achieve minimal risk condition, given the same circumstances*
22 *identified in subdivision 1.*23 *"Dynamic driving task" or "DDT" means all of the real-time operational and tactical functions required*
24 *to operate a vehicle in on-road traffic, including:*25 *1. Lateral vehicle motion control via steering;*26 *2. Longitudinal motion control via acceleration and deceleration;*27 *3. Monitoring the driving environment via object and event detection, recognition, classification, and*
28 *response preparation;*29 *4. Object and event response execution;*30 *5. Maneuver planning; and*31 *6. Enhancing conspicuity via lighting, signaling, and gesturing.*32 *"Dynamic driving task" or "DDT" does not include strategic functions such as trip scheduling and the*
33 *selection of destinations and waypoints.*34 *"Fully autonomous vehicle" means a motor vehicle equipped with an automated driving system designed*
35 *to function without a human driver as a level 4 or 5 system under SAE J3016.*36 *"Human driver" means a natural person in the vehicle with a valid driver's license who controls all or*
37 *part of the dynamic driving task.*38 *"Minimal risk condition" means a condition to which a person, a human driver, or an automated driving*
39 *system may bring a vehicle after performing the DDT fallback in order to reduce the risk of a crash when a*
40 *given trip cannot or should not be completed.*41 *"On-demand autonomous vehicle network" means a digital network that connects passengers to fully*
42 *autonomous vehicles or ADS-equipped vehicles for compensation.*43 *"Operational design domain" means the operating conditions under which a given automated driving*
44 *system is specifically designed to function, including (i) environmental, geographical, and time-of-day*
45 *restrictions and (ii) the requisite presence or absence of certain traffic and roadway characteristics.*46 *"Remote operator" means a natural person who (i) monitors and is capable of controlling an autonomous*
47 *vehicle and (ii) is not physically located in such vehicle.*48 *"Request to intervene" means a notification by an automated driving system to a human driver that the*
49 *human driver should promptly begin or resume performance of part of or all of the dynamic driving task.*50 *"SAE J3016" means the "Taxonomy and Definitions for Terms Related to Driving Automation Systems for*
51 *On-Road Motor Vehicles" published by SAE International on June 15, 2018, as revised.*52 **§ 46.2-1420. Use of fully autonomous vehicles and automated driving systems permissible.**53 *A. A person may operate on the highways in the Commonwealth a fully autonomous vehicle or a motor*
54 *vehicle equipped with an automated driving system capable of performing the entire dynamic driving task*
55 *with the automated driving system engaged without a human driver if the vehicle meets the following*
56 *conditions:*

59 1. The vehicle meets the requirements of this chapter and has been issued an autonomous operation
60 license by the Department;

61 2. If a failure of the automated driving system occurs that renders that system unable to perform the entire
62 dynamic driving task relevant to its intended operational design domain, the vehicle will achieve a minimal
63 risk condition and, if there is a human driver physically present in the vehicle, issue a request to intervene
64 with the expectation that the human driver will respond appropriately to such request;

65 3. The vehicle is capable of operating in compliance with the applicable traffic and motor vehicle safety
66 laws and regulations of the Commonwealth when reasonable to do so, unless an exemption has been granted
67 by the Department;

68 4. When required by federal law, the vehicle bears the required manufacturer's certification label
69 indicating that at the time of its manufacture it has been certified to be in compliance with all applicable
70 federal motor vehicle safety standards, including any exemptions granted by the National Highway Traffic
71 Safety Administration;

72 5. The manufacturer of such vehicle certifies compliance with modern cybersecurity standards to protect
73 the automated driving system from unauthorized remote access or interference; and

74 6. If such vehicle is operated by a remote operator at any time, such remote operator shall (i) possess the
75 proper class of license of the vehicle being operated remotely, (ii) be able to communicate with vehicle
76 occupants in real time through a communication link, (iii) be capable of performing the entire dynamic
77 driving task or achieving a minimal risk condition.

78 B. From July 1, 2026, until July 1, 2028, a fully autonomous vehicle for which the declared gross weight
79 of the vehicle and any towed unit is more than 62,000 pounds shall have a human driver, with the
80 appropriate credentials to operate the vehicle, physically present in the vehicle to monitor the performance of
81 the vehicle and intervene if necessary.

82 C. Prior to operating a fully autonomous vehicle in the Commonwealth without a human driver, a person
83 shall submit a law-enforcement interaction plan to the Department of Transportation and the Department of
84 State Police that describes (i) how to communicate with a fleet support specialist who is available during the
85 times the vehicle is in operation, (ii) how to safely remove the fully autonomous vehicle from the highway and
86 steps to safely tow the vehicle, (iii) how to recognize whether the automated driving system is engaged on the
87 fully autonomous vehicle, (iv) any additional information the manufacturer or owner deems necessary
88 regarding hazardous conditions or public safety risks associated with the operation of the fully autonomous
89 vehicle, and (v) the crash data reporting protocol for the vehicle that requires, in the event of a collision, that
90 automated driving system data logs be provided to the Department of State Police within 48 hours of any
91 such collision.

92 **§ 46.2-1421. Licensing, titling, and registration.**

93 A. The Department shall develop and issue autonomous operation licenses for fully autonomous vehicles
94 and automated driving systems operated in the Commonwealth. The Department shall only issue such
95 autonomous operation licenses to fully autonomous vehicles and automated driving systems that meet the
96 requirements of this chapter. No license shall be issued pursuant to this section unless the manufacturer of
97 such vehicle or system submits a safety case or transparency report detailing how the vehicle or system
98 handles high-stakes ethical dilemmas or forced choice scenarios.

99 B. A fully autonomous vehicle shall be properly titled and registered in accordance with the requirements
100 of Chapter 6 (§ 46.2-600 et seq.). If a fully autonomous vehicle is registered in the Commonwealth, the
101 vehicle shall be identified on the registration as a fully autonomous vehicle. The requirements under this title
102 relating to exhibiting a driver's license and registration card are satisfied if the autonomous operation
103 license and vehicle registration card are in the fully autonomous vehicle and available for inspection by a
104 law-enforcement officer.

105 C. When an automated driving system installed on a motor vehicle is engaged, the automated driving
106 system is considered the driver or operator for the purpose of assessing compliance with applicable traffic or
107 motor vehicle laws and shall be required to satisfy all physical acts required by a driver or operator of the
108 vehicle. However, if a remote operator is actively controlling the vehicle, the remote operator is considered
109 the driver or operator for the purpose of assessing compliance with applicable traffic or motor vehicle laws.

110 **§ 46.2-1422. Financial responsibility requirements.**

111 A. Fully autonomous vehicles shall maintain proof of financial responsibility in the same form and at the
112 same minimum limits required under § 46.2-472 and shall also satisfy uninsured motorist benefits as
113 required by § 38.2-2206.

114 B. An autonomous vehicle with its automated driving system engaged shall maintain proof of financial
115 responsibility in an amount not less than \$1 million combined single limit per occurrence for third-party
116 liability. Proof of financial responsibility under this subsection shall also apply to uninsured motorist benefits
117 as required by § 38.2-2206 when those requirements are not satisfied by insurance or self-insurance under
118 subsection A. Insurers providing insurance policies and self-insurance under subsection A and this
119 subsection may contract and coordinate with each other to determine which will satisfy personal injury
120 protection and uninsured motorist benefit requirements. The satisfaction of financial responsibility under this

121 subsection shall be deemed to satisfy financial responsibility under subsection A.

122 C. Financial responsibility under subsection B may be satisfied by (i) an insurance policy issued by an
123 insurer licensed in the Commonwealth or (ii) a policy issued by an eligible nonadmitted insurer authorized
124 under Chapter 48 (§ 38.2-4805.1 et seq.) of Title 38.2.

125 D. No higher limits of insurance or additional coverages other than the financial responsibility minimum
126 requirement set forth in subsection B shall be required solely due to a vehicle's use of an automated driving
127 system.

128 **§ 46.2-1423. On-demand autonomous vehicle network.**

129 An on-demand autonomous vehicle network shall be permitted to operate in the same manner as, and
130 subject to the same requirements of Chapter 20 (§ 46.2-2000 et seq.) that apply to transportation network
131 companies, except that (i) any provision that reasonably applies only to a human driver shall not apply to the
132 operation of fully autonomous vehicles with the automated driving system engaged on an on-demand
133 autonomous vehicle network and (ii) any provision of this title that would not apply to the operation of fully
134 autonomous vehicles with the automated driving system engaged on an on-demand autonomous vehicle
135 network shall not apply to such vehicles. The Department shall issue guidance on the application of
136 requirements for transportation network companies to an on-demand autonomous vehicle network pursuant
137 to this section. On-demand autonomous vehicle networks shall not be considered a common carrier as
138 defined in § 46.2-2000 and shall not be subject to the requirements of Article 6 (§ 46.2-2074 et seq.) or
139 Article 7 (§ 46.2-2096 et seq.) of Chapter 20.

140 **§ 46.2-1424. Operation of commercial vehicles.**

141 A fully autonomous vehicle that is also a commercial motor vehicle, as that term is defined in
142 § 46.2-341.4, may be operated with the automated driving system engaged, provided that such operation
143 complies with all requirements of this title related to the operation of commercial motor vehicles, except that
144 any provision that by its nature reasonably applies only to a human driver shall not apply to such a vehicle
145 operating with the automated driving system engaged. Any operation of a fully autonomous vehicle that is
146 also a commercial motor vehicle shall comply with any applicable federal requirements for the operation of
147 commercial vehicles.

148 **§ 46.2-1425. Vehicle equipment standards.**

149 A fully autonomous vehicle that is designed to be operated exclusively by the automated driving system for
150 all trips shall not be subject to the provisions of this title, or any regulations promulgated pursuant to such
151 provisions, that both (i) relate to the operation of a motor vehicle by a human driver seated in such vehicle
152 and (ii) do not, by their nature, apply to an automated driving system.

153 **§ 46.2-1426. Penalties.**

154 A. 1. A person or entity that violates this chapter, or a regulation promulgated pursuant to this chapter, in
155 addition to any other penalties provided by law, shall be subject to a civil penalty of not more than \$1,000
156 per offense.

157 2. Each day of a violation of this chapter, or a regulation promulgated pursuant to this chapter, shall
158 constitute a separate offense, and the penalties set forth in this subsection shall be applicable to each
159 separate offense.

160 B. If the Department determines that a fully autonomous vehicle or automated driving system operating
161 under an autonomous operation license is not in safe operational condition and the operation of such vehicle
162 on the highways of the Commonwealth endangers the public, the Department shall provide to the vehicle
163 owner a notice of intent to (i) suspend or revoke the autonomous operation license or (ii) impose restrictions
164 on the operation of such vehicle. For purposes of this subsection, the operation of an autonomous vehicle
165 endangers the public when the operation of such vehicle has resulted in or is likely to result in serious injury
166 or death.

167 C. A notice of intent under subsection B shall (i) include a summary of the Department's determination
168 and evidence supporting the determination, (ii) provide the autonomous operation license holder with a
169 reasonable period to (a) correct the issues identified in the Department's determination and (b) provide to the
170 Department the certification described in clause (ii) of subsection D, and (iii) specify which enforcement
171 actions described by subsection B the Department will take if the autonomous operation license holder fails
172 to provide the required certification within the specified period.

173 D. Before the expiration of the period specified in a notice of intent, the autonomous operation license
174 holder shall (i) ensure the issues identified by the Department in the notice are corrected and (ii) provide to
175 the Department a certification acknowledging that the issues identified by the Department in the notice have
176 been corrected and explaining how the issues have been corrected, including identifying operational
177 measures implemented.

178 E. The Department may extend the period specified in a notice of intent pursuant to subsection D on a
179 written request for an extension that the Department determines is reasonable.

180 F. If the autonomous operation license holder fails to comply with subsection D, the Department shall (i)
181 issue a decision, as specified in the notice of intent, that (a) suspends or revokes the autonomous operation
182 license for the vehicle or (b) imposes restrictions on the operation of the vehicle and (ii) notify the

183 *autonomous operation license holder of such decision.*

184 *G. An autonomous operation license holder who is notified pursuant to subsection F shall be considered*
185 *aggrieved and entitled to an administrative appeal. If an appeal is filed, it shall be scheduled not later than*
186 *60 days after the date of the Department's final determination under this section. If a hearing is not scheduled*
187 *during the period required by this subsection, the autonomous operation license issued under this chapter*
188 *shall be automatically reinstated or the restriction imposed automatically removed, as applicable.*

189 **§ 46.2-1427. Limitations of chapter.**

190 *Nothing in this chapter shall be construed to (i) prohibit a human driver from operating a fully*
191 *autonomous vehicle that controls all or part of the DDT, (ii) prohibit a fully autonomous vehicle from*
192 *operating without a human driver except as provided in subsection B of § 46.2-1420, (iii) prohibit a human*
193 *driver from operating a vehicle with an automated driving system that is not a fully autonomous vehicle with*
194 *such system engaged or disengaged, or (iv) apply to toy vehicles.*

195 **2. That the provisions of this act may result in a net increase in periods of imprisonment or**
196 **commitment. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the necessary**
197 **appropriation cannot be determined for periods of imprisonment in state adult correctional facilities;**
198 **therefore, Chapter 725 of the Acts of Assembly of 2025 requires the Virginia Criminal Sentencing**
199 **Commission to assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4 of the Code of**
200 **Virginia, the estimated amount of the necessary appropriation cannot be determined for periods of**
201 **commitment to the custody of the Department of Juvenile Justice.**
