**Bill Title:** State Government Internship Coordinator; DHRM to establish and employ.

**Bill Summary:** Requires the Department of Human Resource Management to establish the position of and employ a State Government Internship Coordinator to attract high quality interns to the service of the Commonwealth with the goal of developing such interns in a manner that supports their ability to compete for positions in agencies of the Commonwealth upon conclusion of their internships and completion of their educational programs. The bill also requires the Department to establish and administer a system to provide professional development opportunities for state agency interns, intern supervisors, and human resources staff.

**Budget Amendment Necessary:** Yes

**Items Impacted:** 74

**Fiscal Summary:** Preliminary – the Department of Human Resource Management will require additional funding for a full-time position, a part-time wage position, and other nonpersonnel costs related to running an internship program. Any potential impacts to State Council for Higher Education in Virginia are currently unavailable.

**Fiscal Analysis:** This bill requires the Department of Human Resource Management (DHRM) to employ a State Government Internship Coordinator. DHRM will require additional funding to support the salary and benefits of that position, estimated at \$145,224 per year. The department will also require nonpersonnel related funding to support the position, including money for travel, outreach events, marketing materials, and other programming for interns during the course of their internship. The cost for these functions is estimated at

\$15,000. DHRM also estimates the need for a part-time wage position during the summer months when a larger volume of interns is expected. The estimated cost for that wage position is \$15,000 per year.

**Other:** This bill is similar, but not identical, to SB286.
