2 AMENDMENT IN THE NATURE OF A SUBSTITUTE
3 (Proposed by the Senate Committee on Transportation
4 on February 26, 2026)
5 (Patron Prior to Substitute—Delegate Lopez)

6 *A BILL to amend and reenact § 46.2-208 of the Code of Virginia and to amend the Code of Virginia by*
7 *adding a section numbered 15.2-967.3, relating to enforcement of parking violations; certain counties;*
8 *pilot program.*

9 **Be it enacted by the General Assembly of Virginia:**

10 **1. That § 46.2-208 of the Code of Virginia is amended and reenacted and that the Code of Virginia is**
11 **amended by adding a section numbered 15.2-967.3 as follows:**

12 **§ 15.2-967.3. *Parking violations; ticket by mail; pilot program.***

13 *A. For purposes of this section:*

14 *"Authorized county" means any county operating under the county manager plan of government.*

15 *"Authorized equipment" means an automatic license plate recognition system, as that term is defined in §*
16 *2.2-5517, or any other technology performing a similar function.*

17 *B. An authorized county may authorize the use of authorized equipment to enforce the authorized county's*
18 *parking ordinances or regulations. An authorized county may conduct activities using such authorized*
19 *equipment, including capturing parking instance data to determine if a parked vehicle has exceeded the*
20 *permitted parking period in a parking space. Prior to the issuance of any ticket for a violation of such a*
21 *parking ordinance or regulation, an employee of the authorized county shall certify that a violation of such*
22 *parking ordinance or regulation occurred based on information captured by such authorized equipment.*

23 *C. If an employee of an authorized county has determined that a violation of a parking ordinance or*
24 *regulation has not occurred, any information collected by an authorized county through the use of authorized*
25 *equipment for such occurrence shall be deleted within two business days of such determination. If a*
26 *determination has not been made as to whether a violation of such a parking ordinance or regulation has*
27 *occurred or if a determination has been made that a violation of such a parking ordinance or regulation has*
28 *occurred but no ticket is issued, any information collected by an authorized county through the use of*
29 *authorized equipment for such occurrence shall be deleted within 30 business days of the collection of such*
30 *information.*

31 *Information collected by authorized equipment operated pursuant to this section shall be limited*
32 *exclusively to information that is necessary for the enforcement of parking ordinances or regulations.*

33 *Information shall be protected in a database and, except as permitted in subsection F, used only for the*
34 *enforcement of violations of such parking ordinances or regulations. Notwithstanding any other provision of*
35 *law, information collected by authorized equipment shall be used exclusively for the purposes of this section*
36 *and shall not be (i) open to the public; (ii) sold or used for sales, solicitation, or marketing purposes; (iii)*
37 *disclosed to any entity not entitled to such information pursuant to this section; or (iv) used in any court*
38 *proceeding unless such proceeding relates to a violation of such parking ordinances or regulations or is*
39 *otherwise requested by court order.*

40 *D. Information obtained by authorized equipment showing a violation of an authorized county's parking*
41 *ordinances or regulations is evidence of a violation of an authorized county's parking ordinances or*
42 *regulations. A certificate, or a facsimile thereof, sworn to or affirmed by an employee of the authorized*
43 *county, based upon inspection of information collected by such authorized equipment, shall be prima facie*
44 *evidence of the facts contained therein. Any information captured by authorized equipment evidencing a*
45 *violation of any authorized county's parking ordinances or regulations shall be available for inspection in*
46 *any proceeding to adjudicate liability for such violation.*

47 *In the prosecution for any violation of the authorized county's parking ordinances or regulations, prima*
48 *facie evidence that the vehicle described in the ticket issued pursuant to this section was in violation of such*
49 *parking ordinance or regulation, together with proof that the defendant was at the time of such violation the*
50 *owner, lessee, or renter of the vehicle, shall constitute in evidence a rebuttable presumption that such owner,*
51 *lessee, or renter of the vehicle was the person who committed the violation. Such presumption shall be*
52 *rebutted if the owner, lessee, or renter of the vehicle (i) files an affidavit by regular mail with the authorized*
53 *county or the clerk of the general district court, as applicable, that he was not the operator of the vehicle at*
54 *the time of the alleged violation and provides the name and address of the person who was operating the*
55 *vehicle at the time of the alleged violation or (ii) testifies in open court under oath that he was not the*
56 *operator of the vehicle at the time of the alleged violation. Such presumption shall also be rebutted if a*
57 *certified copy of a police report showing that the vehicle had been reported to the police as stolen prior to the*
58 *time of the alleged violation of a parking ordinance or regulation adopted by such authorized county is*
59 *presented to the court adjudicating the alleged violation.*

60 *E. Prior to or upon an authorized county's implementation of a program using authorized equipment for*
61 *the enforcement of violations of the authorized county's parking ordinances or regulations, the authorized*
62 *county shall conduct a public awareness campaign advising the public that the authorized county is*
63 *implementing such a program.*

64 *F. If information collected by authorized equipment pursuant to this section shows that a vehicle is owned,*
65 *leased, or rented by the authorized county, such authorized county may use such information for employee*
66 *disciplinary purposes. An authorized county using authorized equipment pursuant to this section may enter*
67 *into an agreement with another locality for the provision of information collected by such authorized*
68 *equipment related to any vehicle owned, leased, or rented by such other locality, whereby such other locality*
69 *may access and use such information for employee disciplinary purposes.*

70 *G. Any authorized county may contract with and compensate a private vendor to perform activities*
71 *related to the use of authorized equipment for the enforcement of violations of parking ordinances or*
72 *regulations pursuant to this section on behalf of the authorized county and any associated activities,*
73 *including consulting, operations, and administration. Any such agreement shall require such private vendor*
74 *to comply with the requirements of this section. Any such agreement for compensation shall be based on the*
75 *value of the goods and services provided and not on the number of violations paid or monetary penalties*
76 *imposed. Any authorized county or any private vendor contracting with an authorized county pursuant to this*
77 *subsection may assess fees to compensate for activities authorized by this section. Such fees shall not render*
78 *a contract entered into pursuant to this subsection invalid or cause a contract entered into pursuant to this*
79 *subsection to be considered in violation of this subsection's requirement that such an agreement for*
80 *compensation not be based on the number of violations paid or monetary penalties imposed. Any private*
81 *vendor contracting with an authorized county pursuant to this subsection may enter into an agreement with*
82 *the Department of Motor Vehicles, in accordance with the provisions of subdivision B 35 of § 46.2-208, to*
83 *obtain vehicle owner information regarding the registered owners of vehicles who committed a violation of a*
84 *parking ordinance or regulation adopted by such authorized county. Any such information provided to such*
85 *private vendor shall be protected in a database.*

86 *H. When a ticket for a violation of an authorized county's parking ordinances or regulations is issued,*
87 *such ticket may be issued by mailing by first-class mail the ticket to the address of the owner of the vehicle as*
88 *shown on the records of the Department of Motor Vehicles.*

89 *I. Any ticket issued pursuant to this section shall be contestable in the same manner as any other ticket*
90 *issued for the same type of violation.*

91 **§ 46.2-208. Records of Department; when open for inspection; release of privileged information.**

92 A. The following information shall be considered privileged and unless otherwise provided for in this title
93 shall not be released except as provided in subsection B:

94 1. Personal information as defined in § 2.2-3801;

95 2. Driver information, defined as all data that relates to driver's license status and driver activity;

96 3. Special identification card information, defined as all data that relates to identification card status; and

97 4. Vehicle information, including all descriptive vehicle data and title, registration, and vehicle activity
98 data, but excluding crash data.

99 B. The Commissioner shall release such information only under the following conditions:

100 1. Notwithstanding other provisions of this section, medical information included in personal information
101 shall be released only to a physician, a physician assistant, or an advanced practice registered nurse in
102 accordance with a proceeding under §§ 46.2-321 and 46.2-322.

103 2, 3. [Repealed.]

104 4. Upon the request of (i) the subject of the information, (ii) the parent of a minor who is the subject of the
105 information, (iii) the guardian of the subject of the information, (iv) the authorized agent or representative of
106 the subject of the information, or (v) the owner of the vehicle that is the subject of the information, the
107 Commissioner shall provide him with the requested information and a complete explanation of it. Requests
108 for such information need not be made in writing or in person and may be made orally or by telephone,
109 provided that the Department is satisfied that there is adequate verification of the requester's identity. When
110 so requested in writing by (a) the subject of the information, (b) the parent of a minor who is the subject of
111 the information, (c) the guardian of the subject of the information, (d) the authorized agent or representative
112 of the subject of the information, or (e) the owner of the vehicle that is the subject of the information, the
113 Commissioner shall verify and, if necessary, correct the personal information provided and furnish driver,
114 special identification card, or vehicle information. If the requester is requesting such information in the scope
115 of his official business as counsel from a public defender's office or as counsel appointed by a court, such
116 records shall be provided free of charge.

117 5. Upon the written request of any insurance carrier or surety, or authorized agent of either, the
118 Commissioner shall furnish to such requester information in the record of any person subject to the
119 provisions of this title. The transcript shall include any record of any conviction of a violation of any
120 provision of any statute or ordinance relating to the operation or ownership of a motor vehicle or of any
121 injury or damage in which he was involved and a report filed pursuant to § 46.2-373. No such report of any
122 conviction or crash shall be made after 60 months from the date of the conviction or crash unless the
123 Commissioner or court used the conviction or crash as a reason for the suspension or revocation of a driver's
124 license or driving privilege, in which case the revocation or suspension and any conviction or crash pertaining

125 thereto shall not be reported after 60 months from the date that the driver's license or driving privilege has
126 been reinstated. The response of the Commissioner under this subdivision shall not be admissible in evidence
127 in any court proceedings.

128 6. Upon the written request of any business organization or its authorized agent, in the conduct of its
129 business, the Commissioner shall compare personal information supplied by the requester with that contained
130 in the Department's records and, when the information supplied by the requester is different from that
131 contained in the Department's records, provide the requester with correct information as contained in the
132 Department's records. Personal information provided under this subdivision shall be used solely for the
133 purpose of pursuing remedies that require locating an individual.

134 7. Upon the written request of any business organization or its authorized agent, the Commissioner shall
135 provide vehicle information to the requester. Disclosures made under this subdivision shall not include any
136 personal information, driver information, or special identification card information and shall not be subject to
137 the limitations contained in subdivision 6.

138 8. Upon the written request of any motor vehicle rental or leasing company or its authorized agent, the
139 Commissioner shall (i) compare personal information supplied by the requester with that contained in the
140 Department's records and, when the information supplied by the requester is different from that contained in
141 the Department's records, provide the requester with correct information as contained in the Department's
142 records and (ii) provide the requester with driver information of any person subject to the provisions of this
143 title. Such information shall include any record of any conviction of a violation of any provision of any
144 statute or ordinance relating to the operation or ownership of a motor vehicle or of any injury or damage in
145 which the subject of the information was involved and a report of which was filed pursuant to § 46.2-373. No
146 such information shall include any record of any conviction or crash more than 60 months after the date of
147 such conviction or crash unless the Commissioner or court used the conviction or crash as a reason for the
148 suspension or revocation of a driver's license or driving privilege, in which case the revocation or suspension
149 and any conviction or crash pertaining thereto shall cease to be included in such information after 60 months
150 from the date on which the driver's license or driving privilege was reinstated. The response of the
151 Commissioner under this subdivision shall not be admissible in evidence in any court proceedings.

152 9. Upon the request of any federal, state, or local governmental entity, local government group self-
153 insurance pool, law-enforcement officer, attorney for the Commonwealth, or court, or the authorized agent of
154 any of the foregoing, the Commissioner shall compare personal information supplied by the requester with

155 that contained in the Department's records and, when the information supplied by the requester is different
156 from that contained in the Department's records, provide the requester with correct information as contained
157 in the Department's records. The Commissioner shall also provide driver, special identification card, and
158 vehicle information as requested pursuant to this subdivision. The Commissioner may release other
159 appropriate information to the governmental entity upon request. Upon request in accordance with this
160 subdivision, the Commissioner shall furnish a certificate, under seal of the Department, setting forth a
161 distinguishing number or license plate of a motor vehicle, trailer, or semitrailer, together with the name and
162 address of its owner. The certificate shall be prima facie evidence in any court in the Commonwealth of the
163 ownership of the vehicle, trailer, or semitrailer to which the distinguishing number or license plate has been
164 assigned by the Department. However, the Commissioner shall not release any photographs pursuant to this
165 subdivision unless the requester provides the depicted individual's name and other sufficient identifying
166 information contained on such individual's record. The information in this subdivision shall be provided free
167 of charge.

168 The Department shall release to a requester information that is required for a requester to carry out the
169 requester's official functions in accordance with this subdivision. If the requester has entered into an
170 agreement with the Department, such agreement shall be in a manner prescribed by the Department, and such
171 agreement shall contain the legal authority that authorizes the performance of the requester's official
172 functions and a description of how such information will be used to carry out such official functions. If the
173 Commissioner determines that sufficient authority has not been provided by the requester to show that the
174 purpose for which the information shall be used is one of the requester's official functions, the Commissioner
175 shall refuse to enter into any agreement. If the requester submits a request for information in accordance with
176 this subdivision without an existing agreement to receive the information, the request shall be in a manner
177 prescribed by the Department, and such request shall contain the legal authority that authorizes the
178 performance of the requester's official functions and a description of how such information will be used to
179 carry out such official functions. If the Commissioner determines that sufficient authority has not been
180 provided by the requester to show that the purpose for which such information shall be used is one of the
181 requester's official functions, the Commissioner shall deny such request.

182 Notwithstanding the provisions of this subdivision, the Department shall not disseminate to any federal,
183 state, or local government entity, law-enforcement officer, or law-enforcement agency any privileged

184 information for any purposes related to civil immigration enforcement unless (i) the subject of the
185 information provides consent or (ii) the requesting agency presents a lawful judicial order, judicial subpoena,
186 or judicial warrant. When responding to a lawful judicial order, judicial subpoena, or judicial warrant, the
187 Department shall disclose only those records or information specifically requested. Within three business
188 days of receiving a request for information for the purpose of civil immigration enforcement, the
189 Commissioner shall send a notification to the individual about whom such information was requested that
190 such a request was made and the identity of the entity that made such request.

191 The Department shall not enter into any agreement pursuant to subsection E with a requester pursuant to
192 this subdivision unless the requester certifies that the information obtained will not be used for civil
193 immigration purposes or knowingly disseminated to any third party for any purpose related to civil
194 immigration enforcement.

195 10. Upon the request of the driver licensing authority in any foreign country, the Commissioner shall
196 provide whatever driver and vehicle information the requesting authority shall require to carry out its official
197 functions. The information shall be provided free of charge.

198 11. a. For the purpose of obtaining information regarding noncommercial driver's license holders, upon
199 the written request of any employer, prospective employer, or authorized agent of either, and with the written
200 consent of the individual concerned, the Commissioner shall (i) compare personal information supplied by
201 the requester with that contained in the Department's records and, when the information supplied by the
202 requester is different from that contained in the Department's records, provide the requester with correct
203 information as contained in the Department's records and (ii) provide the requester with driver information in
204 the form of a transcript of an individual's record, including all convictions, all crashes, any type of driver's
205 license that the individual currently possesses, and all driver's license suspensions, revocations, cancellations,
206 or forfeiture, provided that such individual's position or the position that the individual is being considered for
207 involves the operation of a motor vehicle.

208 b. For the purpose of obtaining information regarding commercial driver's license holders, upon the
209 written request of any employer, prospective employer, or authorized agent of either, the Commissioner shall
210 (i) compare personal information supplied by the requester with that contained in the Department's records
211 and, when the information supplied by the requester is different from that contained in the Department's
212 records, provide the requester with correct information as contained in the Department's records and (ii)

213 provide the requester with driver information in the form of a transcript of such individual's record, including
214 all convictions, all crashes, any type of driver's license that the individual currently possesses, and all driver's
215 license suspensions, revocations, cancellations, forfeitures, or disqualifications, provided that such
216 individual's position or the position that the individual is being considered for involves the operation of a
217 commercial motor vehicle.

218 12. Upon the written request of any member of a volunteer fire company or volunteer emergency medical
219 services agency and with written consent of the individual concerned, or upon the request of an applicant for
220 membership in a volunteer fire company or to serve as volunteer emergency medical services personnel, the
221 Commissioner shall (i) compare personal information supplied by the requester with that contained in the
222 Department's records and, when the information supplied by the requester is different from that contained in
223 the Department's records, provide the requester with correct information as contained in the Department's
224 records and (ii) provide driver information in the form of a transcript of the individual's record, including all
225 convictions, all crashes, any type of driver's license that the individual currently possesses, and all license
226 suspensions, revocations, cancellations, or forfeitures. Such transcript shall be provided free of charge if the
227 request is accompanied by appropriate written evidence that the person is a member of or applicant for
228 membership in a volunteer fire company or a volunteer emergency medical services agency and the transcript
229 is needed by the requester to establish the qualifications of the member, volunteer, or applicant to operate
230 equipment owned by the volunteer fire company or volunteer emergency medical services agency.

231 13. Upon the written request of a Virginia affiliate of Big Brothers Big Sisters of America, a Virginia
232 affiliate of Compeer, or the Virginia Council of the Girl Scouts of the USA, and with the consent of the
233 individual who is the subject of the information and has applied to be a volunteer with the requester, or on the
234 written request of a Virginia chapter of the American Red Cross, a Virginia chapter of the Civil Air Patrol, or
235 Faith in Action, and with the consent of the individual who is the subject of the information and applied to be
236 a volunteer vehicle operator with the requester, the Commissioner shall (i) compare personal information
237 supplied by the requester with that contained in the Department's records and, when the information supplied
238 by the requester is different from that contained in the Department's records, provide the requester with
239 correct information as contained in the Department's records and (ii) provide driver information in the form
240 of a transcript of the applicant's record, including all convictions, all crashes, any type of driver's license that
241 the individual currently possesses, and all license suspensions, revocations, cancellations, or forfeitures. Such

242 transcript shall be provided at a fee that is one-half the normal charge if the request is accompanied by
243 appropriate written evidence that the person has applied to be a volunteer or volunteer vehicle operator with
244 the requester as provided in this subdivision.

245 14. On the written request of any person who has applied to be a volunteer with a court-appointed special
246 advocate program pursuant to § 9.1-153, the Commissioner shall provide a transcript of the applicant's
247 record, including all convictions, all crashes, any type of driver's license that the individual currently
248 possesses, and all license suspensions, revocations, cancellations, or forfeitures. Such transcript shall be
249 provided free of charge if the request is accompanied by appropriate written evidence that the person has
250 applied to be a volunteer with a court-appointed special advocate program pursuant to § 9.1-153.

251 15, 16. [Repealed.]

252 17. Upon the request of an attorney representing a person involved in a motor vehicle crash, the
253 Commissioner shall provide the vehicle information for any vehicle involved in the crash and the name and
254 address of the owner of any such vehicle.

255 18. Upon the request, in the course of business, of any authorized agent of an insurance company or of
256 any not-for-profit entity organized to prevent and detect insurance fraud, or perform rating and underwriting
257 activities, the Commissioner shall provide (i) all vehicle information, the owner's name and address,
258 descriptive data and title, registration, and vehicle activity data, as requested, or (ii) the driver name, license
259 number and classification, date of birth, and address information for each driver under the age of 22 licensed
260 in the Commonwealth, provided that such request includes the driver's license number or address information
261 of such driver. Use of such information shall be limited to use in connection with insurance claims
262 investigation activities, antifraud activities, rating, or underwriting.

263 19. [Repealed.]

264 20. Upon the written request of the compliance agent of a private security services business, as defined in
265 § 9.1-138, which is licensed by the Virginia Department of Criminal Justice Services, the Commissioner shall
266 provide the name and address of the owner of the vehicle under procedures determined by the Commissioner.

267 21. (For contingent expiration date, see Acts 2023, c. 738, cl. 2) Upon the request of the operator of a toll
268 facility, a traffic light signal violation monitoring system acting on behalf of a government entity, a traffic
269 control device violation monitoring system acting on behalf of a government entity, or the Dulles Access
270 Highway, or an authorized agent or employee of a toll facility operator, a traffic light signal violation
271 monitoring system operator acting on behalf of a government entity, a traffic control device violation

272 monitoring system operator acting on behalf of a government entity, or the Dulles Access Highway, for the
273 purpose of obtaining vehicle owner data under subsection H of § 15.2-968.1, subsection A of § 33.2-504,
274 subsection M of § 46.2-819.1, subsection P of § 46.2-819.3:1, or subsection N of § 46.2-819.5. Information
275 released pursuant to this subdivision shall be limited to (i) the name, physical address, and, if available, email
276 or other electronic address of the owner of the vehicle having failed to pay a toll, comply with a traffic light
277 signal, or comply with a traffic control device or having improperly used the Dulles Access Highway and (ii)
278 the vehicle information, including all descriptive vehicle data and title and registration data of the same
279 vehicle.

280 21. (For contingent effective date, see Acts 2023, c. 738, cl. 2) Upon the request of the operator of a toll
281 facility, a traffic light photo monitoring system acting on behalf of a government entity, or the Dulles Access
282 Highway, or an authorized agent or employee of a toll facility operator or traffic light photo monitoring
283 system operator acting on behalf of a government entity or the Dulles Access Highway, for the purpose of
284 obtaining vehicle owner data under subsection H of § 15.2-968.1, subsection A of § 33.2-504, subsection M
285 of § 46.2-819.1, subsection P of § 46.2-819.3:1, or subsection N of § 46.2-819.5. Information released
286 pursuant to this subdivision shall be limited to the name, physical address, and, if available, email or other
287 electronic address of the owner of the vehicle having failed to pay a toll or having failed to comply with a
288 traffic light signal or having improperly used the Dulles Access Highway and the vehicle information,
289 including all descriptive vehicle data and title registration data of the same vehicle.

290 22-26. [Repealed.]

291 27. Upon the written request of the executor or administrator of a deceased person's estate, the
292 Department shall, if the deceased person had been issued a driver's license or special identification card by
293 the Department, supply the requester with a hard copy image of any photograph of the deceased person kept
294 in the Department's records.

295 28. [Repealed.]

296 29. a. Upon written agreement, the Commissioner may digitally verify the authenticity and validity of a
297 driver's license, learner's permit, or special identification card to the American Association of Motor Vehicle
298 Administrators, a motor vehicle dealer as defined in § 46.2-1500, or another organization approved by the
299 Commissioner.

300 b. Upon written agreement, the Commissioner may release minimum information as needed in the
301 Department's record through any American Association of Motor Vehicle Administrators service program

302 created for the purpose of the exchange of information to any business, government agency, or authorized
303 agent who would otherwise be authorized to receive the information requested pursuant to this section.

304 30. Upon the request of the operator of a video-monitoring system as defined in § 46.2-844 acting on
305 behalf of a government entity, the Commissioner shall provide vehicle owner data pursuant to subsection B
306 of § 46.2-844. Information released pursuant to this subdivision shall be limited to the name and address of
307 the owner of the vehicle having passed a stopped school bus and the vehicle information, including all
308 descriptive vehicle data and title and registration data for such vehicle.

309 31. Upon the request of the operator of a photo speed monitoring device as defined in § 46.2-882.1 acting
310 on behalf of a government entity, the Commissioner shall provide vehicle owner data pursuant to subsection
311 H of § 46.2-882.1. Information released pursuant to this subdivision shall be limited to the name and address
312 of the owner of the vehicle having committed a vehicle speed violation, as defined in § 46.2-882.1, and the
313 vehicle information, including all descriptive vehicle data and title and registration data, for such vehicle.

314 32. Notwithstanding the provisions of this section other than subdivision 33, the Department shall not
315 release, except upon request by the subject of the information, the guardian of the subject of the information,
316 the parent of a minor who is the subject of the information, or the authorized agent of the subject of the
317 information, or pursuant to a court order, (i) proof documents submitted for the purpose of obtaining a driving
318 credential or a special identification card, (ii) the information in the Department's records indicating the type
319 of proof documentation that was provided, or (iii) applications relating to the issuance of a driving credential
320 or a special identification card. As used in this subdivision, "proof document" means any document not
321 originally created by the Department that is submitted to the Department for the issuance of any driving
322 credential or special identification card. "Proof document" does not include any information contained on a
323 driving credential or special identification card.

324 33. Notwithstanding the provisions of this section, the Department may release the information in the
325 Department's records that it deems reasonable and necessary for the purpose of federal compliance audits.

326 34. The Department may release to a party that is subject to an administrative proceeding conducted by
327 the Department nonmedical privileged information necessary to participate in such administrative
328 proceeding. Such information shall be limited to matters of fact and law asserted or questioned by the
329 Department, as are required to be provided pursuant to §§ 2.2-4019 and 2.2-4020. The Department may also
330 release such information to other parties to the same administrative proceeding. Notwithstanding the
331 provisions of subsection E, no information released pursuant to this subdivision shall be disseminated to any

332 third party that is not a party to such administrative proceeding.

333 *35. Upon the request of a private vendor using authorized equipment, as defined in § 15.2-967.3, acting*
334 *on behalf of an authorized county, as defined in § 15.2-967.3, the Commissioner shall provide vehicle owner*
335 *data pursuant to subsection G of § 15.2-967.3. Information released pursuant to this subdivision shall be*
336 *limited to the name and address of the owner of the vehicle having committed a violation of such authorized*
337 *county's parking ordinances or regulations and the vehicle information, including all descriptive vehicle data*
338 *and title and registration data, for such vehicle.*

339 C. Information disclosed or furnished shall be assessed a fee as specified in § 46.2-214, unless as
340 otherwise provided in this section.

341 D. Upon the receipt of a completed application and payment of applicable processing fees, the
342 Commissioner may enter into an agreement with any governmental authority or business to exchange
343 information specified in this section by electronic or other means.

344 E. The Department shall not release any privileged information pursuant to this title unless the
345 Department has entered into a written agreement authorizing such release. The Department shall require the
346 requesting entity to specify the purpose authorized pursuant to this title that forms the basis for the request
347 and provide the permissible purpose as defined under 18 U.S.C. § 2721(b). Privileged information requested
348 by an entity that has been altered or aggregated may be used only for the original purposes specified in the
349 written agreement consistent with this title. The requesting entity shall disseminate privileged information
350 only to third parties subject to the original purpose specified in the written agreement consistent with this
351 title. Any agreement that does not allow third-party distribution shall include a statement that such
352 distribution is prohibited. Such agreement may limit the scope of any authorized distribution consistent with
353 this title. Privileged information distributed to any third party shall only be further distributed by such third
354 party subject to the original purpose specified and consistent with this title, or unless such third party is the
355 subject of the information, the parent of a minor who is the subject of the information, the guardian of the
356 subject of the information, the authorized agent or representative of the subject of the information, or the
357 owner of the vehicle that is the subject of the information.

358 Any agreement entered into pursuant to this subsection between the Department and the Department of
359 State Police shall specify (i) that privileged information shall be distributed only to authorized personnel of
360 an entity meeting the definition of a criminal justice agency as defined in § 9.1-101 and other comparable
361 local, state, and federal criminal justice agencies and entities issued a Virginia S-Originating Agency

362 Identification (S-ORI) status; (ii) that privileged information shall be accessed, used, and disseminated only
363 for the administration of criminal justice as defined in § 9.1-101; and (iii) that no local, state, or federal
364 government entity, through the Virginia Criminal Information Network (VCIN) or any other method of
365 dissemination controlled by the Department of State Police, has access to information stored by the
366 Department in violation of the protections contained in this section. The Department of State Police shall
367 notify the Department prior to when a new entity is to be granted S-ORI status and provide a copy of the
368 S-ORI application to the Department. The Department of State Police shall not allow any entity to access
369 Department data through VCIN if the Department objects in writing to the entity obtaining such data.

370 The provisions of this subsection shall not apply to (a) requests for information made pursuant to
371 subdivision B 4; (b) a request made by an entity authorized to receive privileged information pursuant to
372 subsection B, provided that such request is made on a form provided by the Department, other than a written
373 agreement, that requires the requester to certify that such entity is entitled to receive such information
374 pursuant to this title, state the purpose authorized pursuant to subsection B that forms the basis for the
375 request, explain why the information requested is necessary to accomplish the stated purpose, and certify that
376 the information will be used only for the stated purpose and the information received shall not be
377 disseminated to third parties unless there is authorization to do so; or (c) the release of information to a law-
378 enforcement officer or agency during an emergency situation, provided that (1) the requesting entity is
379 authorized to receive such information pursuant to subdivision B 9, (2) the timely release of such information
380 is in the interest of public safety, and (3) the requesting entity completes the form required pursuant to clause
381 (b) within 48 hours of the release of such information.

382 F. Any person that receives any privileged information that such person knows or has reason to know was
383 received in violation of this title shall not disseminate any such information and shall notify the Department
384 of the receipt of such privileged information.

385 G. The Department shall conduct audits annually based on a risk assessment to ensure that privileged
386 information released by the Department pursuant to this title is being used as authorized by law and pursuant
387 to the agreements entered into by the Department. If the Department finds that privileged information has
388 been used in a manner contrary to law or the relevant agreement, the Department may revoke access.

389 H. Any request for privileged information by an authorized agent of a governmental entity shall be
390 governed by the provisions of subdivision B 9.

391 2. That the provisions of this act shall expire on July 1, 2029.
