**Bill Number:** HB836S1

**Patron:** Rasoul

**Bill Title:** Public schools; right to free public elementary and secondary education; discrimination based on immigration status prohibited; requirements; civil cause of action.

**Bill Summary:** Prohibits any child in the Commonwealth from being denied a free public education through secondary school on the basis of the actual or perceived immigration or citizenship status of the child or the child's parents, in accordance with the Constitution of Virginia and consistent with the requirements of the Fourteenth Amendment to the United States Constitution. The bill prohibits any school board, public elementary or secondary school, school resource officer employed by a local law-enforcement agency in any public elementary or secondary school, or any individual who is an employee, contractor, or agent of a school board from engaging in certain enumerated actions and practices that involve or result in the denial of a free public education, or denial of the benefits or exclusion from participation in any program or activity thereof, of a child on the basis of the actual or perceived immigration or citizenship status of the child or the child's parents. The bill also requires each school board to develop and implement procedures for (i) reviewing and authorizing requests from law-enforcement agents, as that term is defined in the bill, to enter a public school or public school facility and (ii) prohibiting any school board employee, contractor, or agent, or any school resource officer from permitting, assisting with, or participating in the execution of any nonjudicial warrant, as defined by the bill, by a law-enforcement agent present on school property for purposes relating to immigration enforcement or investigation. The bill establishes a civil cause of action for any aggrieved party by conduct that violates the provisions of the bill, in accordance with the provisions of the bill including a requirement to provide written notice to the school division about the alleged violation. The bill directs the Department of Education to develop and make available to each school board by August 1, 2027, guidance for school personnel on the requirements of the bill and training guidelines and materials for the training of all public school principals and administrators on compliance with the provisions of the bill. Finally, the bill directs each school board to (a) develop and implement by the beginning of the 2027-2028 school year policies and procedures in accordance with the provisions of the bill and (b) require each public school principal and administrator to complete training on compliance with the provisions of the bill by the beginning of the 2027-2028 school year.

**Budget Amendment Necessary:** Yes

**Items Impacted:** 123

**Explanation:** The Department of Education (DOE) would require additional staff in order to meet the requirements of the bill. Any impact to local school divisions is indeterminate.

**Fiscal Summary:** DOE anticipates the need for one additional position at an estimated cost of \$135,356 general fund per year including salary, benefits and technology.

DOE anticipates the need for an additional position to help develop these resources and ensure ongoing compliance with the provisions of the bill.

Any impact to local school divisions to implement the new training requirements or other provisions of the bill is indeterminate.
