2 *An Act to amend and reenact § 46.2-739 of the Code of Virginia, relating to vehicle registration fees;*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 46.2-739 of the Code of Virginia is amended and reenacted as follows:**

8 **§ 46.2-739. Special license plates for certain disabled veterans; fees.**

9 A. On receipt of an application, the Commissioner shall issue special license plates to applicants who are
10 veterans who have been certified by the U.S. Department of Veterans Affairs to have a service-connected
11 disability or unremarried surviving spouses of disabled veterans as defined in § 46.2-100. Any special license
12 plate issued to a disabled veteran pursuant to this subsection may be transferred, upon his death, to his
13 unremarried surviving spouse. These license plates shall be special permanent red, white, and blue license
14 plates bearing the letters "DV." The application shall be accompanied by a certification from the U.S.
15 Department of Veterans Affairs that the veteran's disability is service-connected. License plates issued under
16 this subsection shall not permit the vehicles upon which they are displayed to use parking spaces reserved for
17 persons with disabilities that limit or impair their ability to walk.

18 B. On receipt of an application, the Commissioner shall issue special DV disabled parking license plates
19 displaying the international symbol of access in the same size as the numbers and letters on the plate and in a
20 color that contrasts to the background to veterans who are also persons with disabilities that limit or impair
21 their ability to walk as defined in § 46.2-100. The Commissioner shall require that such application be
22 accompanied by a certification signed by a licensed physician, licensed podiatrist, licensed chiropractor,
23 licensed advanced practice registered nurse, or licensed physician assistant to that effect. Special DV disabled
24 parking license plates issued under this subsection shall authorize the vehicles upon which they are displayed
25 to use parking spaces reserved for persons with disabilities that limit or impair their ability to walk.

26 C. No annual registration fee, as prescribed in § 46.2-694, and no annual fee, as set forth in subdivision B
27 3 of § 46.2-725, shall be required for any one motor vehicle owned and used personally by any disabled
28 veteran as defined in § 46.2-100 *who has provided certification that such disability is service related as*
29 *required in subsection A* or the unremarried surviving spouse of such disabled veteran, provided that such
30 vehicle displays *special* license plates issued under this section *or the Department's standard passenger*
31 *license plate issued pursuant to Article 9 (§ 46.2-711 et seq.).*

32 D. The provisions of subdivisions B 1 and 2 of § 46.2-725 shall not apply to license plates issued under
33 this section.
