6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 15.2-947 of the Code of Virginia is amended and reenacted as follows:**8 **§ 15.2-947. Systems of public transportation for certain counties or cities; protection of employees.**

9 A. Notwithstanding any other provision of law, the governing body of any county or city not a member of
 10 a transportation district, upon finding a need for a system of public transportation and the inability of the
 11 governing body to reach a reasonable agreement for membership with an existing transportation district, may
 12 create, operate, maintain, or contract for a system of public transportation to be operated in such county or
 13 city for the safety, comfort, and convenience of the public. The governing body of any such county or city
 14 providing a system of public transportation or desiring to provide such a system may contract with any
 15 authority providing public transportation in contiguous localities for transportation services or the interchange
 16 of passengers for the purpose of providing continuous service between localities.

17 B. *The governing body of any county or city that contracts with a private company to provide a system of*
 18 *public transportation shall, in its bid specifications, project agreements, or other controlling documents,*
 19 *require such company to:*

20 1. *Provide each of its employees (i) compensation at an hourly rate equivalent to the hourly rate paid to*
 21 *an employee of such county or city holding a position requiring equivalent qualifications based on such*
 22 *employee's years of service and the county or city wage progression and (ii) benefits, including health and*
 23 *retirement benefits, that are, at a minimum, actuarially equivalent to the benefits provided to an employee of*
 24 *such county or city with a position requiring equivalent qualifications and years of service;*

25 2. *Provide transportation services through its own employees; and*26 3. *Ensure that all employees of such public transportation system employed by a predecessor private*
27 *company be offered employment with any successor company without loss of compensation or benefits.*28 C. *If a county or city that contracts with a private company to provide a system of public transportation*
29 *subsequently elects to provide its own system of public transportation pursuant to subsection A, such county*
30 *or city shall:*31 1. *Adopt an ordinance or resolution providing for collective bargaining pursuant to subsection A of*
32 *§ 40.1-57.2, if such county or city has not already done so; and*33 2. *Ensure that all employees of the private company are offered employment with such subsequent system*
34 *of public transportation without loss of compensation or benefits.*35 D. *Nothing in this section shall be construed to alter or affect any collective bargaining agreements made*
36 *that may provide compensation lower than the hourly rate equivalent to the hourly rate paid to an employee*
37 *of the county or city holding a position requiring equivalent qualifications based on an employee's years of*
38 *service and the county or city wage progression or provide benefits, including health and retirement benefits,*
39 *that are not at a minimum actuarially equivalent to the benefits provided to an employee of such county or*
40 *city with a position requiring equivalent qualifications and years of service.*41 E. *Nothing in this section shall apply to (i) a commuter rail service jointly operated by the Northern*
42 *Virginia Transportation District Commission established pursuant to § 33.2-1904; (ii) the Potomac and*
43 *Rappahannock Transportation District Commission established pursuant to Chapter 19 (§ 33.2-1900 et seq.)*
44 *of Title 33.2; (iii) a paratransit service provided pursuant to 42 U.S.C. § 12141 et seq.; (iv) a demand*
45 *responsive service or a demand responsive system, as that term is defined in 42 U.S.C. § 12141; or (v) any*
46 *ferry service.*47 **2. That the provisions of § 15.2-947 of the Code of Virginia, as amended by this act, shall apply only to**
48 **actions occurring on or after the effective date of this act. No action taken, contracts signed, liability**
49 **incurred, or right accrued prior to July 1, 2026, shall be affected by this act.**50 **3. That the Director of the Department of Rail and Public Transportation shall convene a work group**
51 **to develop recommendations on how to implement the provisions of § 15.2-947 of the Code of Virginia,**
52 **as amended by this act. The work group shall consist of representatives from localities, transportation**
53 **district commissions established by general law that operate a system of public transit, transit system**
54 **employees, and any other relevant stakeholders. Such work group shall consider (i) how to calculate**
55 **the equivalent qualifications of an employee of the county or city holding a position requiring**
56 **equivalent qualifications based on such employee's years of service; (ii) how to calculate county or city**

57 wage progression for transit employees at a private company providing a system of public
58 transportation; (iii) how to appropriately calculate what compensation at an hourly rate equivalent to
59 the hourly rate paid to an employee of a county or city with a position requiring equivalent
60 qualifications and years of service would be for a transportation commission made up of multiple
61 localities; (iv) how to appropriately calculate benefits, including health and retirement benefits, that
62 are, at a minimum, actuarially equivalent to the benefits provided to an employee of a county or city
63 with a position requiring equivalent qualifications and years of service; (v) the feasibility of and
64 timeline for implementing the requirements described in clauses (i) through (iv); and (vi) how to
65 implement the requirements of § 15.2-947 of the Code of Virginia, as amended by this act, for a
66 transportation commission made up of multiple localities. The work group shall report its findings and
67 recommendations to the Chairs of the House Committee on Labor and Commerce and Senate
68 Committee on Local Government by November 1, 2026.
