HOUSE RESOLUTION NO. 399

WHEREAS, Samina Butt provides leadership and support to her fellow staff members, including assisting substitutes, mentoring new team members, offering help during challenging situations, and celebrating colleagues' contributions; and

WHEREAS, Samina Butt maintains strong collaboration with teachers through daily communication about student behavior, progress, and support needs; and

WHEREAS, Samina Butt extends her care beyond the classroom by checking on students during medical absences, maintaining strong family connections, and demonstrating a strong spirit of service through community involvement and acts of kindness beyond the school setting; and

WHEREAS, through her outstanding achievements, Samina Butt has helped Washington Irving Middle School fulfill its mission to help students grow and achieve academic excellence and develop a strong foundation to become lifelong learners and engaged global citizens; now, therefore, be it
