4 A *BILL to amend and reenact § 44-146.18 of the Code of Virginia and to amend the Code of Virginia*
5 *by adding in Chapter 1 of Title 23 a section numbered 23-9.2:9, relating to crisis and emergency*
6 *management plans for public institutions of higher education.*

Be it enacted by the General Assembly of Virginia:

12 1. That § 44-146.18 of the Code of Virginia is amended and reenacted and that the Code of
13 Virginia is amended by adding in Chapter 1 of Title 23 a section numbered 23-9.2:9 as follows:
14 § 23-9.2:9. *Institutional crisis and emergency management plan; review required.*

15 The board of visitors or other governing body of each public institution of higher education shall
16 develop, adopt, and keep current a written crisis and emergency management plan. Every four years,
17 each institution shall conduct a comprehensive review and revision of its crisis and emergency
18 management plan to ensure the plan remains current, and the revised plan shall be adopted formally by
19 the board of visitors or other governing body. Such review shall also be certified in writing to the
20 Department of Emergency Management. The institution shall coordinate with the local emergency
21 management organization, as defined by § 44-146.16, to ensure integration into the local emergency
22 operations plan.

§ 44-146.18. Department of Emergency Services continued as Department of Emergency Management; administration and operational control; coordinator and other personnel; powers and duties.

25 A. The State Office of Emergency Services is continued and shall hereafter be known as the
26 Department of Emergency Management. Wherever the words "State Department of Emergency Services"
27 are used in any law of the Commonwealth, they shall mean the Department of Emergency Management.
28 During a declared emergency this Department shall revert to the operational control of the Governor.
29 The Department shall have a coordinator who shall be appointed by and serve at the pleasure of the
30 Governor and also serve as State Emergency Planning Director. The Department shall employ the
31 professional, technical, secretarial, and clerical employees necessary for the performance of its functions.

32 B. The State Department of Emergency Management shall in the administration of emergency
33 services and disaster preparedness programs:

34 1. In coordination with political subdivisions and state agencies, ensure that the Commonwealth has
35 up-to-date assessments and preparedness plans to prevent, respond to and recover from all disasters
36 including acts of terrorism;

37 2. Conduct a statewide emergency management assessment in cooperation with political subdivisions,
38 private industry and other public and private entities deemed vital to preparedness, public safety and
39 security. The assessment shall include a review of emergency response plans, which include the variety
40 of hazards, natural and man-made. The assessment shall be updated annually;

41 3. Submit to the Governor and to the General Assembly, no later than the first day of each regular
42 session of the General Assembly, an annual executive summary and report on the status of emergency
43 management response plans throughout the Commonwealth and other measures taken or recommended
44 to prevent, respond to and recover from disasters, including acts of terrorism. This report shall be made
45 available to the Division of Legislative Automated Systems for the processing of legislative documents
46 and reports. Information submitted in accordance with the procedures set forth in subdivision 4 of
47 § 2.2-3705.2 shall not be disclosed unless:

48 a. It is requested by law-enforcement authorities in furtherance of an official investigation or the
49 prosecution of a criminal act;

b. The agency holding the record is served with a proper judicial order; or

51 c. The agency holding the record has obtained written consent to release the information from the
52 State Department of Emergency Management;

4. Promulgate plans and programs that are conducive to adequate disaster mitigation preparedness, response and recovery programs;

55 5. Prepare and maintain a State Emergency Operations Plan for disaster response and recovery
56 operations that assigns primary and support responsibilities for basic emergency services functions to
57 state agencies, organizations and personnel as appropriate;

58 6. Coordinate and administer disaster mitigation, preparedness, response and recovery plans and

59 programs with the proponent federal, state and local government agencies and related groups;

60 7. Provide guidance and assistance to state agencies and units of local government in developing and
61 maintaining emergency management and continuity of operations (COOP) programs, plans and systems;

62 8. Make necessary recommendations to agencies of the federal, state, or local governments on
63 preventive and preparedness measures designed to eliminate or reduce disasters and their impact;

64 9. Determine requirements of the Commonwealth and its political subdivisions for those necessities
65 needed in the event of a declared emergency which are not otherwise readily available;

66 10. Assist state agencies and political subdivisions in establishing and operating training programs
67 and programs of public information and education regarding emergency services and disaster
68 preparedness activities;

69 11. Consult with the Board of Education regarding the development and revision of a model school
70 crisis and emergency management plan for the purpose of assisting public schools in establishing,
71 operating, and maintaining emergency services and disaster preparedness activities;

72 12. Consult with the State Council of Higher Education in the development and revision of a model
73 institutional crisis and emergency management plan for the purpose of assisting public and private
74 two-year and four-year institutions of higher education in establishing, operating, and maintaining
75 emergency services and disaster preparedness activities *and, as needed, in developing an institutional*
76 *crisis and emergency management plan pursuant to § 23-9.2:9;*

77 13. Develop standards, provide guidance and encourage the maintenance of local and state agency
78 emergency operations plans;

79 14. Prepare, maintain, coordinate or implement emergency resource management plans and programs
80 with federal, state and local government agencies and related groups, and make such surveys of
81 industries, resources, and facilities within the Commonwealth, both public and private, as are necessary
82 to carry out the purposes of this chapter;

83 15. Coordinate with the federal government and any public or private agency or entity in achieving
84 any purpose of this chapter and in implementing programs for disaster prevention, mitigation,
85 preparation, response, and recovery;

86 16. Establish guidelines pursuant to § 44-146.28, and administer payments to eligible applicants as
87 authorized by the Governor;

88 17. Coordinate and be responsible for the receipt, evaluation, and dissemination of emergency
89 services intelligence pertaining to all probable hazards affecting the Commonwealth;

90 18. Coordinate intelligence activities relating to terrorism with the Department of State Police; and

91 19. Develop an emergency response plan to address the needs of individuals with household pets and
92 service animals in the event of a disaster and assist and coordinate with local agencies in developing an
93 emergency response plan for household pets and service animals.

94 C. The State Department of Emergency Management shall during a period of impending emergency
95 or declared emergency be responsible for:

96 1. The receipt, evaluation, and dissemination of intelligence pertaining to an impending or actual
97 disaster;

98 2. Providing facilities from which state agencies and supporting organizations may conduct
99 emergency operations;

100 3. Providing an adequate communications and warning system capable of notifying all political
101 subdivisions in the Commonwealth of an impending disaster within a reasonable time;

102 4. Establishing and maintaining liaison with affected political subdivisions;

103 5. Determining requirements for disaster relief and recovery assistance;

104 6. Coordinating disaster response actions of federal, state and volunteer relief agencies;

105 7. Coordinating and providing guidance and assistance to affected political subdivisions to ensure
106 orderly and timely response to and recovery from disaster effects.

107 D. The State Department of Emergency Management shall be provided the necessary facilities and
108 equipment needed to perform its normal day-to-day activities and coordinate disaster-related activities of
109 the various federal, state, and other agencies during a state of emergency declaration by the Governor or
110 following a major disaster declaration by the President.

111 E. The State Department of Emergency Management is authorized to enter into all contracts and
112 agreements necessary or incidental to performance of any of its duties stated in this section or otherwise
113 assigned to it by law, including contracts with the United States, other states, agencies and government
114 subdivisions of the Commonwealth, and other appropriate public and private entities.

115 F. The State Department of Emergency Management shall encourage private industries whose goods
116 and services are deemed vital to the public good to provide annually updated preparedness assessments
117 to the local coordinator of emergency management on or before April 1 of each year, to facilitate
118 overall Commonwealth preparedness. For the purposes of this section, "private industry" means
119 companies, private hospitals, and other businesses or organizations deemed by the State Coordinator of
120 Emergency Management to be essential to the public safety and well-being of the citizens of the

121 Commonwealth.
